1. Governance

a) Leadership Team Mandates – (see appendix A)

2020-03-13_024 MOTION (M. Grenon/D. Macdonald) that the Conseil régional Nakonha:ka Regional Council Executive receives the Leadership Team Mandate for the Governance Handbook (with names removed) from the Planning Regional Council Gatherings Leadership Team. **Carried**

b) Licenced Lay worship Leaders – Motion continued from Feb. 14

2020-03-13_025 MOTION (S. Dansokho/M. Grenon) that the Conseil régional Nakonha:ka Regional Council Executive agrees with the recommendations of the Licenced Lay Worship Leaders to lived practice, including a bi-annual interview and relicensing process; the administrative task of verifying that Police Records Checks and mandatory training courses are up to date be taken over at the Regional Council level; and that permission be granted to conduct Funerals when the deceased has no particular affiliation with a Community of Faith or when the ministry personnel is confirmed as unavailable. **Carried**

Rational of information for edits to the LLWL Handbook:

- a. There is ample time to meet LLWL'S and flag any possible problems during the twice-a-year Enrichment Days and because the interview process is time consuming, we recommend a biannual interview and relicensing process.
 - The interviews can be organized by the Leadership Team but carried out by retired LLWL'S or Ministers who are not part of the Leadership Team, in order to provide an unbiased assessment.
- b. The administrative task of verifying that Police Records Checks and mandatory training courses are up to date be taken over at the Regional or National level. As the guidelines state that LLWL's are expected to meet the same ethical standards as Ministry Personnel, our team suggests that this administrative function be handled in the same way via Church Hub. Alternatively, on a bi-annual basis only our interview team could record and provide the Regional Council with the dates each LLWL has received their required training / police checks.
- c. The nature of rural ministry as well as the declining financial resources of some urban churches at times requires more frequent requests for any one LLWL than that stipulated in the current Handbook e.g. Both Harrington Harbour and Metis Beach have only one Lay Worship Leader each. Both sites are without permanent Ministry Personnel. From time to time this same situation occurs in other areas of our Region where there are no other LLWL'S or available ministers within easy travel distance. We therefore recommend elimination of the maximum number of services within a single Community of Faith, with the proviso that this situation be flagged at the bi-annual interview

Discussion: It was decided not to approve the above (c.) recommendation, and to keep current policy in place, and deal with cases on an individual basis.

d. Funerals: Part of the ongoing training offered to LLWL's in the Eastern Townships has been on how to conduct a funeral. Many ministry personnel consider the willingness of LLWL'S to perform funerals an aid to their own ministry, particularly when the deceased has no particular

<u>affiliation</u> with a Community of Faith or when the ministry personnel is unavailable. Although more extended pastoral care is certainly a welcome feature of funeral preparation, nevertheless our experience has found that our LLWL's can offer a sympathetic and pastoral presence in the preparation and leadership of funerals.

Mundie) that the 2019 Nakonha:ka Regional Council draft financial statements be presented for information at the Regional Council Executive meeting on Friday March 13, and that the final version be presented for approval at the Regional Council Executive meeting on Friday April 17. An evaluation of market events as of March 31 will be made to determine if a post-audit note is required particularly to the valuation of the investment portfolio in view of present market instability. MOTION (P. Bisset/P. Mundie) that the Property and Finance Leadership Team recommend to the Regional Council Executive an increase of \$20,000 in the St James United Church loan. CARRIED.

Clinker) that the Property and Finance Leadership Team supports the efforts of Wesley United Church (Bedford) and recommends to the Regional Council Executive the transfer of the property to the Finance & Extension Board to handle the sale, with the policy on proceeds of sale remaining in place and the net proceeds not to be distributed until the Regional Council Executive approves the distribution plan. Whereas in the 1950's and 60's the Town of Dolbeau was created by Lake St John Power & Paper Company Limited (an international paper company) and lands were allocated for both the Roman Catholic and Protestant churches and cemeteries;

Whereas the land for the Protestant cemetery was vested in Dolbeau Community Church (formerly United Church of Dolbeau) and since that time was maintained by faithful of the latter, most notably Mr. Edgar Hopkins;

Whereas section 6 of the United Church of Canada Act, as ratified by the Québec Legislature, deems such property to be the property of the United Church of Canada, subject to the authority of local Trustees;

Whereas the Dolbeau Community Church, following the destruction of its church building in 1975, has been disbanded and its church building returned to the successor of the international paper company, but the property of the Dolbeau Protestant Cemetery was not dealt with;

Whereas the United Church Manual 2019 Section C.2.6 (b) now expressly authorizes Regional Councils to make "decisions on the property of communities of faith remaining after the communities of faith cease to exist"; and

Whereas the local Protestant community, including the remaining United Church of Canada faithful, have requested the United Church to transfer its rights to Dolbeau Pentecostal Church (Église Pentecôte de la Moisson de Dolbeau) which has agreed to maintain and otherwise care for the Dolbeau Protestant Cemetery including the graves of United Church of Canada faithful:

RESOLVED that the Conseil Régional Nakonha:ka Regional Council of the United Church of Canada, representing the United Church of Canada, and on the recommendation of its Property and Finance Leadership Team, formally transfers to the said Dolbeau Pentecostal Church the property (lot 2 910 114) presently belonging to the United Church of Canada and/or Dolbeau Community Church and/or United Church of Dolbeau, accepting as full consideration its promise to maintain and otherwise care for the cemetery in conformity with applicable Québec regulations and authorizes any one of its Secretary and Executive Minister Rev. Rosemary Lambie, its President Rev. Linda Buchanan or its Chair of Finance & Property Leadership Team, Me. Frederick Braman, or their mandatory by power of attorney to sign any documents necessary or useful to carry our this resolution.

RESOLVED further that the Regional Council express, on behalf of the United Church of Canada, its heartfelt thanks to Mr. Edgar Hopkins and his daughter Brenda, for their loving care of the Dolbeau Protestant Cemetery for many years. **Carried**
