1. Pastoral Relations

Lambie) that the Conseil régional Nakonha:ka Regional Council Executive on the recommendation of the Pastoral Relations Team, approves the reappointment of Beryl Barraclough, Designated Lay Minister, beginning July 1st 2020 and ending June 30th 2021, part-time (20 hours) to SouthWest United Church. **Carried**
- b) **2020-05-07_062 MOTION** (D. Macdonald/D. Lambie) that the Conseil régional Nakonha:ka Regional Council Executive on the recommendation of the Pastoral Relations Team, declared a full time vacancy for the Harrington Harbour Pastoral Charge, a shared ministry with the Anglican Church of Canada, effective immediately. **Carried**

3. Granting and Enabling Leadership Team – Barbara Bryce; deadline is May 22nd to receive applications and they will be decided on in June.

Nurturing Social Justice and Outreach programs

4. Community of Faith/ Clusters/Networks

- a) **Westmount Park** A team is working on how the large facility might be redeveloped as a non-profit and hopefully a relationship can begin with members of Mountainside.
- b) **Camino de Emaus** Their letter (correspondence c) provided an update and they also submitted a request for funding. It was noted that Kelley Trust has just approved the Camino request for 3 months funding.
- c) Clusters/Networks David-Roger presented a proposal for care of clergy and lay ministers (see appendix C) –

Braman) that the Conseil régional Nakonha:ka Regional Council Executive approve the request for \$1,500 to support care of clergy and lay ministers initiative, using funds from the budget Cluster and Networks, schedule 5 in the income statement (up to \$5,000) set up through the Regional Council as outlined in proposal (appendix C). **Carried**

- 5. Youth and Young Adults, and Family Ministries Shanna/Joëlle Youth Forum online, met on Saturday April 18th (duration of 4 hours) 30 people participated; 3 young adult leaders, 2 leaders from Eastern Ontario Outaouais Regional Council, 3 special guests (artist, social worker, university chaplain). United Spirit Camp will not be gathering this year due to uncertainty with Covid19. In lieu, online presence will happen during the week that the camp was scheduled. The Team met, will continue to meet monthly, during its recent meeting, recapped what is being done currently, and beginning to identify people currently not on the team, looking at starting Messy Church in the Regional Council. Rendezvous 2020 is being re-imagined as having online sessions instead. T-shirts and tuques are being sold.
- **6. La Table** Ministerial Network is meeting regularly every Tuesday morning. Letter that was sent from the Regional Council was well received.
- 7. **Community and Justice Leadership Team** nothing new to report since last meeting, hope to bring more information to the Regional gathering on May 30th.
- **8. Indigenous Ministry** There is continued concern for isolated communities, especially the Heiltsuk community who have faced many young suicides recently. All were asked to keep these communities in their thought and prayers.

Items of interest will be in this week's newsletter. News-worthy stories about how the Church is working during this time (beyond its own walls) need to be shared.
