- 10. Discussion ensued regarding rules surrounding membership on the Executive, designation of youth and young adult (under 30 or 35?) and whether someone who is not an official Lay delegate of a community of faith can be representative of a Leadership Team on the Executive.

11. Regional Council Meetings – Tami Spires provided an update on the planning team progress as it prepares for its meeting in June. The worship Team is meeting next week to begin planning worship during the AGM. Linda Buchanan spoke to the policy in the Governance Handbook (revisions to annual meeting policy, see appendix **D**). Further revisions will be considered and brought back to this meeting based on feedback (i.e., financial statements are not ready for reporting in March, the report book is designed as an annual report to the General Council).

12. Finance and Extension Board – Peter Bisset informed that a report will be submitted in-time for the annual general meeting in June. Bursary applications are being received.

Cluster Development Work

- For the West-Island Cluster, the collaboration continues for sharing on-line worship on the 5th Sundays, the next one being on 30 May. The celebration will conclude with small group discussions around the question "Who Are We Called To Be?".
 - I continue to develop my role as facilitator of the process for this cluster.
- For the St. Francis Cluster group, the group will start next week to use the new book "Thriving Churches" as a tool for reflection in order to weave together common projects between communities of faith.

 The Communities of Faith celebrated an on-line shared worship for Palm Sunday, which had a very good participation.
 - I continue to develop my role as facilitator of the process for this cluster.
- I continue to contact potential participants in an eventual Châteauguay-Richelieu Cluster.

Network Development Work

The Right Relations Network is currently visioning a new way of organizing as a result of a lack of time for several in leadership. For the moment, the work seems to be gravitating towards a project-oriented organization. The next meeting of the "Pride & Friends" Network will be 19 May at 19h00 on Zoom.

I continue to support Judy Coffin in the development of an Environment Network, and I remain in contact with the Justice and Communities Network.

Support to Ministers

The monthly on-line support group for pastors continues to develop with a very faithful participation. We celebrated our 1st anniversary of the monthly group this week, and people expressed a willingness to continue. It should be noted that the time demands in the portfolio of Pastoral Relations, in the form of individual support, has decreased significantly these past months. I also continue my efforts in recruitment.

Support to Retired Ministers

I continue my contacts with retired ministers by phone. The booklet of prayers and meditations for the seasons of Lent-Easter and Pentecost has been sent out, with some feedback being received.

I would like to thank my colleagues for their assistance in its completion, especially Judy Coffin, Brian Ruse, Denis Fortin, Lou Lamontagne, Rosemary Lambie, Shanna Bernier and Joel Miller and all those who contributed ideas and suggestions for this edition.

I have begun to assemble a team of retired pastors to articulate a long-term strategy in order to respond to the needs of retired ministers.

After 14 months of discussion, bridge rebuilding, and many "behind the scenes" conversations, Montréal-West United Church was the hosting congregation for the Christian Commemoration of the Shoah on April 11th. Appendix C¹

Communications report for Executive meeting - April 15, 2021

Supporting leadership teams and networks

Ongoing priorities include supporting the **COVID response team** in sharing updates as provincial guidelines and interfaith protocols have been changing frequently over the past weeks. Plans are underway to develop some sort of flow chart or other method to help guide queries from communities of faith to relevant resources and guidelines more effectively.

I continue to support the **Regional Council meeting planning team** with a) actions ensuing from motions approved at the March 20th meeting (letters to government officials were sent out regarding the prioritization of COVID vaccination for indigenous people across Quebec as proposed by the **Living Into Right Relations team** and we are working in conjunction with General Council to develop public-facing communications reiterating the United Church of Canada support for same-sex unions); and b) by providing follow-up information to the planning team (including survey results and a compilation of table group notes).

The fledgling **Environment Network** is also starting to gain cohesion with some support from staff in scheduling meetings, creating space for defining mission and connecting with national resources such as For the Love of Creation, the Green Churches network and ROJEP (through our representative Richard Guay).

A **reminder** is now being sent out regularly to representatives of leadership teams before each newsletter to remind them of the submission deadline (Friday prior to newsletter) for any stories or information they may wish to share.

Newsletter

The **bilingual newsletter** is sent out every two weeks and currently remains the primary method of sharing information with our members. The average open rate is 56.0% (the industry average rate is only 49.9%). The plan is to continue to direct readers to the web site where possible and to avoid sending a lot of separate messages in addition to the newsletter, unless they are urgent.

Web site

New pages are being developed as resources for networks and leadership teams on demand with a dedicated space for tagged blog posts that will automatically show up on relevant pages (i.e. posts tagged with COVID and YAYA would show up on both of those pages, in addition to the home page and the news page.) There is some work to be done regarding **analytics and plug-ins**, hopefully with some support from GC team. The goal is still to encourage RC members to make more use of the web site.

Social media

Hootsuite, a platform I had started using for managing multiple social media streams, recently underwent some significant changes limiting the range of services available through their free plan so pre-scheduled social media posts, such as the series based on the UCC New Creed, now take a bit more time and planning to execute on a regular basis. Our **public Facebook page and private group** remain the primary channels used on social media for RC communications; **Twitter and Instagram** are used less frequently. In the last 28 days, post reach on Facebook page is up 25% and engagement is up 15%. On the private Facebook group, 60-day post engagement is up 128% over the previous 60-day period.


Facebook and Twitter are also channels where recent national social justice campaigns such as #GuaranteedLivableIncome have gained traction and had positive outcomes through grassroots support.

Common hashtags for posts regarding RC information include **#Nakonhaka**, **#UCCan** and **#egliseunie**. When possible, relevant communities of faith, pastoral charges or leadership teams are also highlighted with hashtags (eg. #MountRoyalUC, #TrinityAnjouPC, #LIRR).

Special projects

The National Post recently published a poll of religious Canadians suggesting that 56% (or 61% for the 55+ crowd) would like to continue having access to online services after the pandemic. We are currently gathering some people with experience and expertise to offer a **webinar on online worship**, including some of the technological recommendations and potential costs.

A digital communications/social media webinar is still in development and awaiting some feedback and input from General Council communications team.

I also continue to serve on an EDGE Network Advisory team looking at future directions for the church, and supporting ongoing transition and transformation.

Appendix D

Current version in the Governance Handbook

Annual Meeting

The Regional Council will meet in person for the first year 2019 and the Executive will make a recommendation to the Regional Council regarding future annual meetings.

Annual Meeting Requirement

The Manual C.4.1

The regional council must meet at least annually.

The annual meeting may be a meeting of the entire regional council or the executive of the regional council, as determined by the regional council.

Meetings: General

The Manual C.4.2

The regional council must decide

- a) whether and, if so, how often it will meet regularly between annual meetings as the entire regional council or the executive;
- b) the time and place for the annual and other regular meetings, and the procedure for calling annual and other regular meetings; and
- c) how it will hold special meetings for urgent business between regular meetings.

Minimum numbers of members

Minimum Number of Members at Meetings

The Manual C.4.3

The regional council may meet only if a minimum number of members is present. For meetings of either the regional council or its executive,

- a) if there are fewer than 60 members, at least 1/3 of them must be present;
- b) if there are 60 or more members, at least 20 members must be present; and
- c) there must be at least one ministry personnel and one lay member who is not ministry personnel present.

Corresponding members are not counted for this purpose.

The Executive may make a recommendation to the Regional Council in 2020 regarding minimum numbers of members.

Proposed revised version to amend the Governance Handbook

Regional Council Annual General Meetings

In accordance with *The Manual C.4.1 & C.4.2*

The Planning Leadership Team, in collaboration with the President, will hold the authority and responsibility for the date, timing, agenda, location, logistics, worship, and all other details involved in holding a Regional Council General Meeting. The Planning Leadership Team can empower sub-Teams to do specific work.

April 15, 2021 Zoom Teleconferencing

The Regional Council will hold 3 General Meetings on an Annual basis;

Fall meeting, entirely online, will include but not be limited to:

- a) the task of approving the budget for the upcoming year,
- b) liturgy to covenant with Regional Council Licensed Lay Worship Leaders (every second year)

[Annual Meeting] Winter meeting, entirely online, will include but not be limited to:

- a) accepting reports on the work of the preceding calendar year which will form The Annual Report booklet of the Regional Council. All Leadership Teams will include a written report; other written reports will be encouraged, including reports from Networks, Clusters, Regional Council Staff, and other Partners in Ministry.
- b) making any changes to the Regional Council Governance Handbook.

Spring meeting, in-person with the ability to join online, will include but not be limited to

- a) [accepting] the work and recommendations from the Office of Vocation regarding Ordinations, Commissioning, and Admissions.
- b) accepting the work of the Regional Council Nomination Leadership Team (including voting on Commissioners and executive members).
- c) Celebration of Ministry
- All General meetings will include worship and relationship building opportunities along with the task within the above seasonal schedule. When possible, a meeting can include guest speakers, workshops, and other suitable activities.

In between General Meetings the Regional Council Executive will be commissioned to make decisions on behalf of the Regional Council, including all urgent business.

Minimum numbers of members

Minimum Number of Members at Meetings

The Manual C.4.3

The regional council may meet only if a minimum number of members is present. For meetings of either the regional council or its executive,

- a) if there are fewer than 60 members, at least 1/3 of them must be present;
- b) if there are 60 or more members, at least 20 members must be present; and
- c) there must be at least one ministry personnel and one lay member who is not ministry personnel present. Corresponding members are not counted for this purpose.
