Dave noted there is a sense of tiredness and this reflects on the lack of interests in joining the Executive. There is a vacancy on nomination.

Discussion: It was noted that there still needs to be consensus on what is the age for YAYA representative (is it under 35 like how the Province sees youth)? The Nominations Team will work with YAYA to write up a recommendation to help provide consensus on what the age of YAYA should be.

Fred Braman reiterated who the *members of the Reginal Council are* referring to the Manual 2021. A list of YAYA representative will be drawn up and circulated to the Executive for an email vote prior to the AGM on June 12th.

C.1.2 Lay Members

Communities of faith that are congregations or pastoral charges continue to elect representatives to the regional council in the same way they elected representatives to the presbytery prior to January 1, 2019. They may also change the way in which they elect

representatives within denominational policies, with the agreement of the regional council, and by including it in the covenant between the community of faith and regional council.

The lay members of the regional council are members of the United Church who are not ministry personnel and who are

- a) elected by communities of faith on the following basis:
- i) one representative from each community of faith with 100 or fewer members:
- ii) two representatives from each community of faith with 101 to 200 members;
- iii) three representatives from each community of faith with 201 to 300 members;
- iv) four representatives from each community of faith with more than 300 resident members; and
- b) additional lay members as determined by the regional council if necessary to respect a balance of ministry personnel and lay members who are not ministry personnel in the membership of the regional council. (2021) The regional council determines for itself the best way to respect this balance which may include adding lay members to ensure diversity or particular experience and competencies within the regional council.

Darryl Macdonald has agreed to extend time as rep for Pastoral Relations for one more year, as have Fred Braman for Property and Finance LT and Rick Sheffer for New Ministries LT.

LLWL Enrichment Day Summary – April 24th 2021

Opening and welcome: Charlotte Griffith

Worship: Don Wood

Scripture: Lamentations 3: 19-24

Reflection: Hope. Hope emanates from faith. God's love is as fresh as the morning and as sure as the sunrise. Shared the rescue story of 13 children and their coach caught in a cave in Thailand. Miracles still happen in the 21st century.

Morning Session with Rev. Wayne Beamer: Preaching that Engages

*Background information – see attachments from Rev. Beamer

Discussion "around the table" about the Good Samaritan parable:

- *who are our neighbours? Anyone that we come into contact with
- *how do we attain eternal life? Kindness to others, reaching out, being a good neighbour
- *compassion: antimaskers how do their actions affect others?
- *being a good neighbour? The George Floyd situation and the responses of others to what happened to him.
- *covid and global society and issues: the teacher of the law wanted to justify himself
- *it was the religious people who passed by the man who had been beaten question of altruism: do we help because we are internally good or is there a benefit to us?
- *it is not always easy to be a good neighbour
- *loving God and being a good neighbour: sometimes it is hard to be a good neighbour; someone comes up to your car at a stop light looking for money can create feelings of fear, trepidation, nervousness; sometimes it is hard to do the right thing
- *...and he was moved to compassion: vaccination process which countries have served themselves first?

The Samaritan put himself into action. How do we convince folks to go and get vaccinated?

The Samaritan gave money to the innkeeper. We have to be generous in our actions.

- *When the lawyer stood up to address Jesus it was the keeping of the law that was most important for him compassion
- *the man lying by the side of the road: the first vision was of George Floyd. No one really jumped in to do anything. The person filming the scene was an observer and didn't help out. (out of fear perhaps?)
- *lack of compassion and empathy in the Good Samaritan parable. The elderly

Asian lady in NYC who was knocked down by a big man. Lack of compassion still today.

- *the George Floyd situation: little compassion shown by folks even though they were there watching (again, out of fear perhaps?)
- *neighbourly act situation: supposition the robber was not properly employed so he robbed the man; the innkeeper trusted the Samaritan to pay him
- *in Montreal: beautiful flowers and trees on one side of a street while on the other side there was nothing; the people who planted the trees and flowers are good Samaritans
- *the person in the ditch was being judged for his race, colour, etc...We haven't evolved very far (George Floyd situation); even the smallest gestures should be noted
- *the generosity of strangers always surprises us. Covid lockdown and stress and antidotal stories of generosity virtual choirs; the factory in Knowlton that prepared meals for the truckers delivering to the factory

*who is your neighbour? Acts of benevolence – when a neighbour could not care for her 3-month old son, Hepta's mother adopted the boy and he became her brother

1. Purpose

The Conseil Régional Nakonha:ka Regional Council ("the Regional Council") is a branch of the United Church of Canada, constituted under the *United Church of Canada Act* (1926). The Regional Council incorporates communities of faith and outreach ministries from the former Consistoire Laurentien and Consistoire du Québec Presbytery. The Regional Council oversees its constituent churches, missions, and outreach ministries, adopting measures to promote their religious life. Service is directed towards its members and the ecumenical and secular society within its geographic bounds, particularly the poor.

Effective January 1, 2019 the presbyteries and conference courts of the United Church of Canada across Canada were replaced with 16 independent regional councils. As such the Québec Presbytery of the United Church of Canada ceased operating as at December 31, 2018 having realized all of its assets, satisfied its liabilities and remitted all of the remaining funds to the Conseil Régional Nakonha:ka Regional Council which continued with the charitable status of the Québec Presbytery. The Regional Council also succeeded to all the assets and liabilities of the Québec Presbytery, the Consistoire Laurentien and a portion of the Montréal and Ottawa Conference as agreed with Eastern Ontario Outaouais Regional Council.

In order to maintain its registered charity status, the Regional Council must meet certain spending requirements ("disbursement quota") according to the *Income Tax Act*. The disbursement quota is a minimum amount that the registered charity must spend on charitable programs or as gifts to qualified donees in order to maintain its registered charity status. As at December 31, 2020, the Regional Council complied with the requirement.

2. Accounting policies

These financial statements have been prepared in accordance with Canadian generally accepted accounting standards for Not-for-Profit organizations using the restricted fund method of accounting for contributions.

Fund accounting

The General Unrestricted Fund accounts for all current operations and programs of the Regional Council.

The Internally Restricted Fund is a contingency reserve fund created by the Regional Council.

The Restricted Funds account for and report all activities of the following externally imposed restrictions:

The Heritage Archives Fund

The Archives Fund was established as a result of the United Church of Canada Policy whereby Pastoral Charges contribute 2% from the sale proceeds of closing or amalgamating congregations to a maximum contribution of \$5,000. The funds are to be used to assist with the care and maintenance of the archival records of the closing or amalgamating pastoral charge, and to assist Archivists in meeting the demand in processing, arranging and describing the records so that they are accessible for future generations for continuing use.

The Heritage Trust Fund was formed to provide financial support for the Montréal and Ottawa Conference archives and to be an on-going fund source to ensure the support and preservation of the heritage of the United Church and its antecedent denominations in the Regional Council area.

During the year, the above two funds were combined into the Heritage Archives Fund.

2. Accounting policies (continued)

Financial instruments

The Regional Council initially measures its financial assets and financial liabilities at fair value, except for certain related party transactions that are measured at the carrying amount or exchange amount, as appropriate.

The Regional Council subsequently measures all its financial assets and financial liabilities at amortized cost, except for investments in equity instruments, bonds that are quoted in an active market, which are measured at fair value. Changes in fair value are recognized in net income.

Financial assets measured at amortized cost include cash and accounts receivable.

Financial liabilities measured at amortized cost include accounts payable and accrued liabilities.

There are no financial assets measured at fair value.

Impairment

Financial assets measured at cost are tested for impairment when there are indicators of impairment. The amount of the write-down is recognized in net income. The previously recognized impairment loss may be reversed to the extent of the improvement, directly or by adjusting the allowance account, provided it is no greater than the amount that would have been reported at the date of the reversal had the impairment not been recognized previously. The amount of the reversal is recognized in net income.

Transaction costs

The Regional Council recognizes its transaction costs in net income in the period incurred. However, the carrying amount of the financial instruments that will not be subsequently measured at fair value is reflected in the transaction costs that are directly attributable to their origination, issuance or assumption.

Revenue recognition

Grants and donations are recognized when received or receivable has been confirmed. Revenue from pastoral charges is recognized on the accrual basis and when collection is reasonably assured.

Accounting for a controlled not-for-profit organization

The Regional Council elected not to consolidate the accounts of a controlled not-for-profit organization. Summary financial information is provided in Note 6.

Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for notfor-profit organizations requires management to make estimates and assumptions that affect the amounts of assets and liabilities as well as the disclosure of contingent assets and liabilities at the date of the financial statements. Such estimates and assumptions also affect revenues and expenses during the period. Actual results could differ from these estimates.

4. Related party transactions and balance

The Regional Council is a branch of the United Church of Canada from which it received grants during the year.

The grant from and the due to the Finance and Extension Board in the financial statements was received from and is payable to a controlled registered charity as described in Note 6.

The due to the Finance and Extension Board is non-interest bearing with no fixed repayment terms.

The transactions have been valued in these financial statements at the exchange amount which is the amount of consideration established and agreed to by the related parties.

5. Interfund transfer and internal restriction

At its November 21, 2020 general meeting, the Regional Council, when adopting the 2021 Budget, decided that any amounts which would otherwise be considered operation surpluses for 2020 and 2021 would be contributed in its financial accounts to a Contingency Reserve Fund for the expenditures that are very likely to become necessary in 2021-2023 inter alia to compensate for needs of the Regional Council and its constituent communities of faith caused directly or indirectly by the COVID-19 pandemic. This decision also applies to the operation surplus shown in its 2019 Financial Statements. The Regional Council or its Executive may decide at any time to authorize expenditures to be charged to the Contingency Reserve Fund.

6. Commitments

The Regional Council has an operating lease agreement for its premises which expires June 30, 2022. The future minimum lease payments over the next two years are as follows: 2021 - \$26,700; and 2022 - \$13,716.

7. Controlled not-for-profit organization

The Regional Council controls the Finance and Extension Board of the Conseil Régional Nakonha:ka Regional Council (the "Board"). The Board, a registered charity, manages the funds entrusted to it, acquires and helps maintain buildings within the Regional Council and provides sabbatical and bursary funds. The Board is also empowered to promote and carry on mission work with a concern for the spiritual and temporal welfare of the church, which is accomplished through its programs and annual grants transferred to the Regional Council.

According to the Board's constitution, the Regional Council elects the members of the Board, approves the Board's budget, and any changes to the By-Laws of the Constitution of the Board. The financial information of the Board has not been consolidated in the Regional Council's financial statements. Financial statements of the Board are available on request. Financial summaries of the Board as at December 31, 2020 and 2019 and for the periods then ended are as follows:

8. Financial instruments

Risks and concentrations

The Regional Council is exposed to various risks through its financial instruments, without being exposed to concentrations of risk. The following analysis provides a measure of the Regional Council's risk exposure at the balance sheet date, December 31, 2020.

Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Regional Council's main credit risks relate to its accounts receivable from former pastoral charges. As of January 1, 2019, the Regional Council no longer collects pastoral charges.

9. Other information

Good Samaritan Fund

The Good Samaritan Fund was established as a donor-directed fund with the United Church of Canada Foundation following the closure and sale of the Griffith-McConnell Residence (an outreach mission of the Regional Council). The terms of the Agreement with the Foundation provide that the Regional Council may alone designate grants from the income of the fund to ministry programs involving seniors in the Province of Québec.

The maximum annual amount of the grant is a variable percentage of the fund balance. If the Regional Council fails to designate grants, then the Foundation has the right to make grants to similar causes that year anywhere in Canada to comply with their disbursement quota under tax regulations. The fund balance at the end of 2020 was \$7,418,224 (2019 - \$7,040,238)

The total 2020 annual grant amount designated by the Regional Council from the Good Samaritan Fund was \$315,554 (2019 - \$229,961).

Financial impact of COVID-19

Events have occurred as a result of the COVID-19 (coronavirus) pandemic that have caused economic uncertainty. The duration and impact of the COVID-19 pandemic, as well as the effectiveness of government responses, remain unclear at this time. Management has implemented an emergency assistance program for communities of faith at the discretion of the Regional Council. The overall impact of these events on the Regional Council and its activities is too uncertain to be estimated at present. The financial impacts will be accounted for when they are known and can be evaluated.

Dear Regional Council Executive/ Property and Finance Leadership Team,

Following the Policy Regarding proceeds from the Sale of Property (September 2019) of the Conseil régional Nakonha:ka Regional Council, The Trustees of Centenary United Church are presenting the distribution of the proceeds of the sale, the fees resulting from the sale, the ensuing ministry plan, and an estimated yearly budget adopted by the Congregation on May 6,2021.

The Centenary community of faith recognizes our mission statement as foundational, forming the guiding principles for designing our mission plan and future ministry:

"Centenary United is a Christian Community of Faith serving the Pointe St. Charles area of Montreal. Our Christian faith inspires our sense of community. We recognize and celebrate God's love for all of creation through our worship and fellowship. We seek to be a loving, friendly community that worships God and serves others. Come as you are – we would love to get to know you."

The Trustee's of Centenary United Church is presenting the subsequent Ministry Proposal and the Plan of Distribution of the Net Proceeds of the Sale of 585 Fortune Street building of Centenary United Church to the Regional Council Executive as follows;

- 1. The Congregation intends to continue its worship and programing services at Saint Columba House on the present arrangements for the foreseeable future. It is understood that any future donations otherwise than in the context of its partnership with Saint Columba House will require advance Regional Council
- 2. The Congregation is planning to develop a pastoral care program for the community of faith and the broader community of Point St. Charles using a portion of the interest from the investment and the
- 3. To collaborate with Saint Columba House to broaden the Senior's program in Point St. Charles;
- 4. The trustees are recommending the Plan of Distribution, including the budget of the community of faith, as follows;
- a) 10% to Healing Fund for the Indigenous Communities of the United Church of Canada
- b) 10% to the Finance and Extension Board of the Conseil régional Nakonha:ka Regional Council for future church development in this region;
- c) 25% to a Continuing Ministry Fund for Centenary United Church to be held by its Trustees under the Congregational Investment Program of the United Church of Canada Foundation and to be disbursed for the ministry of that Community of Faith in the context of its partnership with Saint Columba House, subject to the prior consent of the Conseil régional Nakonha:ka Regional Council;
- d) 22% to be retained by the Trustees of Centenary United Church for the operations of that Community of Faith:
- e) 9% to Saint Columba House for its operations;
- f) 9% to Montreal City Mission endowment fund to support the legal and advocacy work with refugees;
- g) 9% to Saint Columba House for its Endowment Fund and future ministry;

h) 6% to the Mission and Service Fund of the United Church of Canada with \$15,000 earmarked for justice and human rights work with the United Church of Christ – Philippines.

The final agreed-upon price of the property is \$1,050,000. The change in the last offer is related to the finding of asbestos in the basement and an oil tank. So a motion to amend the motion of April 9 is necessary.

Motion 1. "RESOLVED that the Regional Council Executive amend its April 9, 2021 motion concerning the sale of the Centenary United Church property to ratify the reduction by the Centenary United Church Trustees of the price to read \$1,050,000 according to the terms of the Amendment AM13320 of April 20, 2021, and confirm the authority of the said Trustees to conclude the said sale and make any further adjustments, if required, up to \$25,000."

I am attaching a document detailing the distribution of \$998,800.00, describing the \$51,200.00 of sale's fees and the pro-format budget for a typical year \$ 21,300.00 for the Congregation. The deed will be signed on July 6, 2021.

The funds held in trust and the amount designated for active use provides room for growth, innovative ministry, and new partnerships.

Wesley United Church Ministry Plan and Legacy Fund

Our Mission Statement:

Spread God's love, Share our Riches

The congregation of Wesley United Church met in Stanbridge East United Church hall on Friday, April 9, 2021 to formulate a plan for the proceeds from the sale of our historic church building at 53 River Street, Bedford, Quebec. It has consulted with its members and proposes the following.

Vision of ministry

Our vision for ministry sees a number of new ventures that we can do better together between the Bedford Pastoral Charge and the Cowansville Area Pastoral Charge rather than separately (for example we now share ministry personnel). We see:

- Creative and lively worship, including Bible Study using multimedia resources (i.e. the purchase of equipment or supplies).
- Outreach to seniors in the area, both in seniors' facilities and in their own homes. We envision offering programs for seniors and maintaining contact with those living on their own.
- Outreach to children and youth in the neighbourhoods within the Bedford Pastoral Charge, through family resources and schools.
- Since we consider our place of worship and cemetery as an expression of ministry, we will maintain both our place of worship and our cemetery in a good state of repair.
- Co-ordinate together with local organisations and the Bedford Charge's Outreach Committee for the needs and projects of the community.

Legacy gifts to the United Church

The remittances to the United Church for Indigenous Ministry, its Regional Council and Archives relate to the sales of church buildings as of 2020. They were not policy on buildings sold before that date. The congregation wishes that these legacy offerings contribute to the life and vitality of ministry and mission in the United Church. The amounts are:

1.	Indigenous Ministry	\$ 15,799.24
2.	Regional Council	\$15,799.24
3.	Archives	\$ 3, 159,85

The congregation concurs with these amounts and invites into celebration what these legacy monies mean for the life and mission of our wider church. This is an opportunity to educate a new generation as to the evolution of ministry in relationship with our indigenous communities and the new regional structure of our denomination.

The Wesley congregation continues its commitment to support Mission & Service in its yearly budget and declines to give a one-time gift at this time.

Legacy Fund

Of the remaining monies Wesley Congregation will invest and distribute funds that will be known as Wesley United Church Legacy Fund.

Not more than 5% can be used for administrative needs.

The congregation will support United Church missions and local charities as it has done in the past and will donate up to \$7,500 annually from its fund.

The remaining members of the congregation are the de facto committee of the fund and will meet in person twice a year. Agreement on distribution of monies may be agreed to by email.

This ministry plan will be submitted to our regional council and its Finance and Extension Board by the chair of the Wesley United Board.

Report for YAYA Leadership Team

Team members: Jillian Lalonde (Co-Chair), Joëlle Leduc (Co-Chair, Currently on parental leave), Gary Tompkins, Bailey Eastwood, Rachel Lambie, Denis Ashby (interim executive representative), Virginia Wallace, Ellie Hummel (Corresponding member), Judith Bricault, Jean-Daniel Williams, Georgia Barett-Lamey, Esther Guillen, Jennifer Carroll & Shanna Bernier (Staff).

The Yaya Leadership team feels that we accomplished many goals and enjoyed intentional growth of our team in the past year, which is cause for celebration. Despite working in a time of extreme change and disruption to the programming model that youth-ministry has used for decades, we managed to host events, reach out to children, youth, and young adults teams and deepen our relationships with different parts of the United Church.

In terms of significant program development, there were two programs which offered activities and Christan education for children and youth.

- For more than a year, Children's church at home has been offering a weekly worship program on Facebook live, and the accompanying Facebook page is a space for regular updates and resources related to children and family ministry.
- In June 2020, United Spirit Camp went online and created a week-long program for children connected to our camp, as well as a mail-out to all past campers from the 2 previous years. As a spin-off from the week of camp, we hosted 3 seasonal Campfires online, with singing, story-telling and connection. In 2021, United Spirit Camp is very pleased and excited to have received a grant from the Federal Government for two staff positions, to run a 3-week long online program in July, as well as creating and mailing out camp boxes which were developed in partnership with the Pacific Mountain Regional Council.

Many of the members of our team participated in and led Rendez-vous online in August of 2020. The experience was a mix of joyful and frustrating moments. We felt first-hand how a large scale online event can both increase and complicate accessibility. Following our experience and reflection, our team wrote and co-signed a letter to the Moderator and General Secretary explaining some of our frustration with the lack of Bilingual content, and the failure to invite or accommodate Francophone youth as a part of an ongoing pattern with the Rendez-vous events. We received a reply, and we hope that we can continue the conversation about exclusion and welcome of our Francophone members. As a part of this particular issue, we forged new connections with La table des Ministère en Francais. We hope to continue to do more collaboration in the areas of shared priority ex: resources for children's ministry.

Due to the collective trauma we have all been facing, a lot of Shanna's work this year was focused on Pastoral care to the YaYa community. This was achieved in ongoing support and the "Yaya Check-In" calls which happen almost every Thursday, as well as the creation and mailing of over 100 Care packages in the Fall of 2020 and the Spring of 2021.

Our YAYA leadership team supports and facilitated other youth led spin off programming, by the sharing of professional ZOOM accounts. One of our young leaders, Ben Ryan, created a Tuesday night Dungeons & Dragons group, which is open to beginners and youth from all backgrounds and circumstances. The participants are mostly folks who have attended Youth Forum and camp, and it is lovely to see community building transported to a new place, led by young people who have been a part of our Regional Council programs.

Not all online programming took off; Shanna attempted 3 creative young adult workshops last summer, but beautiful weather, lower covid restrictions, and ZOOM fatigue led to very low participation.

When we are visioning for the future, and the hope of reopening and returning to some face to face events in the Fall, we have a few named priorities:

- The creation of a Francophone lead youth event
- Sustaining and creating more intentional young adult ministry and hosting another retreat for young adults.
- Hosting a regional Messy Fiesta to encourage and support congregations who are hoping to start their own Messy Church ministry.

In conclusion, the YaYa leadership team remains enthusiastic, hopeful and committed to providing quality, accessible experiences of Church and community for people in the first third of their lives. We are grateful for the ongoing support and recognition of this important ministry.

Appendix I

Communications report for Executive meeting – May 20, 2021

Rather than share a list of tasks, objectives and accomplishments this month, I would like to offer a conversation starter. Through all the research and engagement that happens through my role as communications person, various resources and needs emerge on a regular basis, and so I offer the following for consideration.

FOR DISCUSSION: assessing potential / need to develop and support some new Regional Council connections based on common interests, roles or objectives, such as:

- a) pastoral care ***
- b) technology
- c) church administrators/secretaries (communicators)
- d) music
- e) other TBD

THE SEED

The initial seed for this conversation is the new rollout of tools in ChurchHub, but this also inspired some thoughts of how these tools might be useful in a larger context.

Ongoing developments in ChurchHub/D365 include having communities of faith add the contact information for people who serve in various roles such as Board Chair, Board Secretary, Music Director, etc. I have also requested the addition of **Church Office Admins/Secretaries** (vital info), as well as the possibility of identifying **Tech teams** and **Pastoral Care teams** (valuable info).

THE FRUIT

Through my role in regional communications, participation in various national events and groups (such as the advisory team for EDGE) and my continued connection with the ORA Loss & Living Program at Ste. Genevieve United Church, there are some common threads emerging regarding the need for conversations and accompaniment through the grief wave that already exists and will continue post-COVID. I feel that it may be useful for us as a Regional Council to strengthen and support a healthy pastoral care network as we continue to navigate COVID and post-COVID needs of our communities of faith, and wider communities. Having a better sense of existing resources as provided by communities of faith through ChurchHub could be a starting point to help us to identify our current strengths in order to support further development of both pastoral care networks and technological expertise networks across the Regional Council as we face a brave new world post-COVID.

In particular, **building and strengthening a pastoral care network** across our Regional Council could be a win-win-win initiative for:

- a) supporting ministry personnel in providing pastoral care (as well as receiving it),
- b) giving a new sense of purpose to members of communities of faith and
- c) building a sense of trust and connection with wider communities, all of whom could benefit from compassionate care as we all deal with the fallout from collective COVID grief and loss.

A few years ago, Family Life Centre hosted a weekend seminar on pastoral care with a panel of presenters and small group activities; if there is interest, perhaps something like this could be adapted to an online format which could also be recorded and used again as a video resource for in-person workshops (for areas without good internet connection or Zoom capability) once COVID guidelines allow gatherings again.

There is also a related **opportunity to train or develop more individuals as community connectors** (increasing the number of people in communities who are aware of community resources and are able to refer people to relevant contacts, events, activities and resources offered by churches, social services, health services,

recreational services, etc.) using the Compassionate Communities model documented by Dr. Julian Abel and Lindsay Clarke in the book "The Compassion Project" (I have access to four copies in the ORA Loss & Living Program library if anyone is interested). This model demonstrated a 17% reduction in emergency admissions by tackling issues of isolation and loneliness; partly by increasing the number of knowledgeable people throughout the community with a two-hour training, resulting in those connectors being able to refer and direct people to social, mental, physical and spiritual resources in the course of their normal interactions at the community level (friends, family, colleagues, etc.); and partly by developing stronger relationships between health care providers, municipalities and community organizations, including churches.

RESOURCES AND POTENTIAL PARTNERS

As Rosemary has pointed out to me, many are still struggling to navigate ChurchHub. Maybe we could start by ensuring that all of our communities of faith have access to a regional team of ChurchHub mentors?

The training of community connectors could likely be done in our Regional Council in conjunction with community organizations such as West Island Resource Centre (and their equivalent organizations in other areas of the province). Through my connection with ORA Loss & Living Program at Ste. Genevieve United Church, I have also been working with the Community Development Manager at Montreal Institute of Palliative Care over the past few years to increase awareness of the Compassionate Communities model.

This direction towards community collaboration and partnerships would also be very much in line with the Soul of Community initiative that was being promoted through Saint Columba House and Montreal City Mission over the past couple of years and the overall goal of being a more relevant church in the world, by supporting our vulnerable neighbours in alignment with other community organizations. Cedar Park United Church has also been working on developing an intentional Caring Community model for several years, and I am sure there are others within our Regional Council with similar backgrounds and experience.

A recent West Island community council meeting online gathered communities of faith and charitable organizations together to discuss how common causes and energies could be shared, with an introduction to the Waybase platform for Canadian churches and charities. I followed up with some of my connections at General Council and EDGE for some insight about Waybase and other tools that might be available through EDGE for connecting people and information for community collaboration, including demographic assessments of local communities and their needs.

Big picture: wondering how and if we might encourage, promote and support the development of these types of community connections; it could also strengthen our internal sense of connection and being mutually supported while communicating to people in local communities that the local church still has relevance to their daily lives, whether they are currently churchgoers or not... and that they are not alone!

Appendix J

Annual Meeting

The Regional Council will meet in person for the first year 2019 and the Executive will make a recommendation to the Regional Council regarding future annual meetings.

Annual Meeting Requirement

The Manual C.4.1

The regional council must meet at least annually.

The annual meeting may be a meeting of the entire regional council or the executive of the regional council, as determined by the regional council.

Meetings: General

The Manual C.4.2

The regional council must decide

- a) whether and, if so, how often it will meet regularly between annual meetings as the entire regional council or the executive;
- b) the time and place for the annual and other regular meetings, and the procedure for calling annual and other regular meetings; and
- c) how it will hold special meetings for urgent business between regular meetings.

Minimum numbers of members

Minimum Number of Members at Meetings

The Manual C.4.3

The regional council may meet only if a minimum number of members is present. For meetings of either the regional council or its executive,

- a) if there are fewer than 60 members, at least 1/3 of them must be present;
- b) if there are 60 or more members, at least 20 members must be present; and
- c) there must be at least one ministry personnel and one lay member who is not ministry personnel present.

Corresponding members are not counted for this purpose.

The Executive may make a recommendation to the Regional Council in 2020 regarding minimum numbers of members.

Regional Council Annual General Meetings

In accordance with *The Manual C.4.1 & C.4.2*

The Planning Leadership Team, in collaboration with the President, will hold the authority and responsibility for the date, timing, agenda, location, logistics, worship, and all other details involved in holding a Regional Council General Meeting. The Planning Leadership Team can empower sub-Teams to do specific work.

The Regional Council will hold 3 General Meetings on an Annual basis;

- 1) Between January and April, entirely online, will include but not be limited to:
 - a) accepting reports on the work of the preceding calendar year which will form The Annual Report booklet of the Regional Council. All Leadership Teams will include a written report; other written reports will be encouraged, including reports from Networks, Clusters, Regional Council Staff, and other Partners in Ministry.
 - b) making any changes to the Regional Council Governance Handbook.
- 2) Between May and August, in-person with the ability to join online, will include but not be limited to
 - a) [accepting] the work and recommendations from the Office of Vocation regarding Ordinations, Commissioning, and Admissions.
 - b) accepting the work of the Regional Council Nomination Leadership Team (including voting on Commissioners and executive members).
 - c) Celebration of Ministry
 - 3) Between September and December, entirely online, will include but not be limited to:
 - a) the task of approving the budget for the upcoming year,
 - b) liturgy to covenant with Regional Council Licensed Lay Worship Leaders (every second year)
- All General meetings will include worship and relationship building opportunities along with the task within the above seasonal schedule. When possible, a meeting can include guest speakers, workshops, and other suitable activities.

In between General Meetings the Regional Council Executive will be commissioned to make decisions on behalf of the Regional Council, including all urgent business.

Minimum numbers of members

Minimum Number of Members at Meetings

The Manual C.4.3

The regional council may meet only if a minimum number of members is present. For meetings of either the regional council or its executive,

- a) if there are fewer than 60 members, at least 1/3 of them must be present;
- b) if there are 60 or more members, at least 20 members must be present; and
- c) there must be at least one ministry personnel and one lay member who is not ministry personnel present. Corresponding members are not counted for this purpose.
