Whereas the previously accepted offers for the church property of Dorval-Strathmore United Church have not resulted in closing,

RESOLVED that the Conseil régional Nakonha:ka Regional Council Executive concurs with the recommendation of the Property and Finance Leadership Team to replace the January 20, 2022 motion concerning the sale of the Church Property of Dorval-Strathmore United Church by the following:

RESOLVED that Conseil régional Nakonha:ka Regional Council concur with the request of the Trustees of Dorval-Strathmore United Church (now part of Lakeshore Trinity United Church) to sell to Jean Béliveau on behalf of a corporation being formed, their Church Property, located at 310 Brookhaven Avenue, Dorval, QC H9S 2N7 – Lot 1,522,613 on an as-is, where-is basis for \$1,900,000 on the terms of the signed and accepted Counter-Proposal dated March 19, 2022, on the basis that the transaction close on or before May 20, 2022.

RESOLVED that the Regional Council's resolution of October 21, 2022 regarding the Use of Proceeds by the said Trustees continues to apply except as amended by the terms of resolution of November 18, 2021 for the amalgamation of Dorval-Strathmore United Church into Lakeshore Trinity United Church effective January 1, 2022. **CARRIED** 

## f) Italian Church of the Redeemer

**2022-04-07\_013 MOTION** (F. Braman/P. Bisset) that the Conseil régional Nakonha:ka Regional Council Executive concurs with the recommendation of the Property and Finance Leadership Team that an extension of the closing deadline for the offer to purchase to May 31, 2022.

RESOLVED that Conseil régional Nakonha:ka Regional Council concurs with the Trustees of the Italian Church of the Redeemer to extend the deadline from March 31, 2022 to May 31, 2022 for the closing of the Accepted Offer of October 24, 2021, as previously approved by the Regional Council, to purchase their church property (6980 rue Papineau, Montréal, QC, H2E 2G5 – Lot 3 792 346 du Cadastre du Québec) by l'Église Baptiste Évangélique Gethsémané. **CARRIED** 

# g) Mid-Laurentian United Church (Rawdon)

**2022-04-07\_014 MOTION** (F. Braman/P. Bisset) that the Conseil régional Nakonha:ka Regional Council Executive concurs with the recommendation of the Property and Finance Leadership Team that Mid-Laurentian United Church (Rawdon) hold an in-person Congregational Meeting (when pandemic restrictions allow), chaired by a representative of Regional Council, other than the incumbent minister, to vote on the sale of the church building. It is suggested, and if possible directed, that this meeting be combined with the Congregational Annual Meeting, the business to precede the vote of the proposed sale. **CARRIED** 

Discussion: Cemetery is looked after by a committee; church portion only would be sold. It was suggested that the Regional Council provide resources to help congregations which are contemplating difficult decisions or actively grieving when decisions effectively close their church. It was suggested to propose the resource ORA Loss & Living Program. Judy Coffin has volunteered to follow up with ORA to discuss what resources can be made available to congregations fitting this description. It was suggested to perhaps create a budget line for supportive resources for congregations needing

mediation, etc. to help facilitate during potential conflicts that may arise when congregations have to face difficult decisions.

#### h) Lacolle United Church

**2022-04-07\_015 MOTION** (F. Braman/P. Bisset) that the Conseil régional Nakonha:ka Regional Council Executive concurs with the recommendation of the Property and Finance Leadership Team to approve the following resolution:

RESOLVED that Conseil régional Nakonha:ka Regional Council, on the recommendation of its Property & Finance Leadership Team, concurs in the request of the Trustees and Congregation of Lacolle United Church to transfer its land and building (1 route de l'Église nord, Lacolle, Lot 4,938,719) to the Lacolle Municipality for the sum of \$1.00 with the covenant to renovate and use the property as a public library and possibly a community kitchen, with the proviso that the terms of the Deed of Transfer shall be approved in advance by the Regional Council's Property & Finance Leadership Team (or its representative). **CARRIED** 

Discussion: City has committed to spend \$350,000 over the next three years to upgrade the building.

## i) Union (Montreal) United Church

**2022-04-07\_016 MOTION** (F. Braman/P. Stanfield) that the Conseil régional Nakonha:ka Regional Council Executive concurs with the recommendation of the Property and Finance Leadership Team to concur with the request of both parties to amend the terms of the Loan Agreement of Union United Church (Montréal) with the Finance and Extension Board going forward with the covenant to make an immediate lump sum payment of \$36,505.48 and thereafter annual payments of \$25,000 on July 1 of each year until the loan principal is fully paid.

As recommended by the Treasurer of CrNRC and the F&E Board Finance Committee for accounting purposes, the accounts of the CrNRC and the F&E Board will indicate that the interest portion of the loan with Union United Church will be posted in the form of a grant from the Regional Council to Union United Church on an annual basis in the amount of \$21,372 (paid directly to the Finance and Extension Board from CrNRC).

The loan amendment will reflect the restructured payment plan. All other elements of the original loan agreement remain in effect. The amendment will require signature of the Chair and Treasurer of the Official Board of Union United. The F&E Board authorizes the President or any officer to sign the amendment to the loan agreement with Union United Church. **CARRIED** 

Discussion: A motion could come from the RC requesting that the principle be paid by the F&E to the RC to pay the interest on the loan made by the F&E to Union UC.

## 5. Community of Faith/ Clusters/Networks

a) Opening of Churches – Peter Bisset reported that currently the only legal restriction is that masks must be worn. The RC still encourages safe practices (distancing, hand washing, etc.). Although vaccine passports are not legally mandated, churches can still require them. Concern was raised, that despite the removal of most restrictions, Covid continues to spread and it is the hope that churches remain vigilant.

## -Christian-Jewish Dialogue

David-Roger highlighted the hurt caused during the GC 44 preparatory meeting last evening. GC 44 Commissioners have been invited to a listening session set up by through Christian-Jewish dialogue.

It was suggested that a treasure/accountant be resourced to the St-Francis Cluster to fill a vacancy.

Judy highlighted she welcomes suggestions for how to do more than broadcast information, and creat a space for Communities of Faith to voice concerns and facilitate community building within the Regional Council. In terms of broadcasting information, Judy welcomes suggestions for focusing in on broadcasting what is needed (newsletter is becoming too long and less focused). There is concern that Communities of Faith may not be getting summaries (or are getting very limited summaries) of what is taking place at a RC level by their representative.
- **10.** Nominations Rev. David Lambie, nothing to report at this time.
- 11. Regional Council Meetings –Rev. Linda Buchanan reported that the team had its wrap-up meeting and on April 21<sup>st</sup> will begin planning for June. LIRR and members of Community and Justice Teams will be present and part of the planning. Linda provided some of the details of the agenda. Lakeshore Trinity will be the venue.
- **12. Finance and Extension Board** Peter Bisset, nothing to report at this time.

**New Business** – An Honorary Doctorate will be awarded to Rev Cathy Hamilton from the United Theological College and Linda will extend congratulations to her on behalf of the Executive.

**Equity Monitor Reporting** – Samuel highlighted there was a positive tone during this meeting. Samuel showed concern for voices that were missing from the table (in particular Indigenous Ministry being absent today). Samuel reiterated the importance for communication and suggested that maybe a different order in the agenda be used – some were showing their fatigue towards the end of the meeting.

## **Supporting Networks and Clusters**

# **Cluster Development Work**

- For the *West Island Cluster*, the next Combined Worship will be held on 29 May in person at Union Church (Merging Waters). We will have the joy of baptizing little Jacqueline Lisa Owers-Leduc during this celebration. The celebration will also be broadcast on the Web.
- For the *Saint-Francis Cluster*, the group will explore Chapter 3 of "Thriving Churches" together in April. The group continues a dialogue around the construction of a collaborative ministry in response to the question of food insecurity.
- The process of establishing a Cluster on the South Shore as well as the Richelieu and Châteauguay valleys is bearing fruit. Several conversations have been had, and the first steps for a new cluster have been taken. To start with, there will be an invitation to a "daily de-brief" conversation at the end of the afternoon of each day of the Homiletics Festival in May, gathering ordained and lay ministers to share their experience of the programme of each day. There will also be a first "Ministerial" gathering of ordained and lay ministers for these two regions in May. The invitation will be sent out after Easter. Given that there is one United Church congregation in this group that has a collaboration with two Presbyterian congregations, this project will be occumenical. Exploratory conversations have begun to plan an outdoor celebration of several congregations in August, followed by an inter-congregational picnic.

# **Network Development Work -Leadership Teams and Circles**

- The « *Living in Right Relations* » Leadership Circle will participate in the next planning meeting for the June General Assembly. The Circle will offer an awareness-deepening animation at the June General Assembly.
- The « *Pride & Friends* » Network: Thanks to Rita Beauséjour and Charles Dougherty for having accepted to animate the workshop during the General Assembly in March. Two new people have joined the Steering Committee for the Affirm United Process.
- The « *Environment* » Network: Thank you to Judy Coffin for coordinating the report as well as the PowerPoint presentation for the General Assembly in March. Thank you to Wendy Evans for her presentation, as well as Neil Whitehouse, Natacha Sanson, and Lee Ann Hogle for their help and participation in the animation of the workshop.
- The « *Justice & Communities* » Leadership Team is planning a meeting at the end of April, beginning of May.

# Christian-Jewish Dialogue of Montréal

The Christian-Jewish Dialogue of Montréal has sent a letter to Moderator Richard Bott, to General Secretary Michael Blair, as well as the General Council, and to Executive Minister Rosemary Lambie and the Conseil régional Nakonha:ka Regional Council expressing the concerns which arise from the report "Just Peace". ## Soutien aux réseaux et aux regroupements

# Travail – développement des Regroupements

- Pour le regroupement de *l'Ouest de l'Île*, la prochaine célébration conjointe de culte aura lieu le 29 mai en personne à l'Église Unie Union Church (Merging Waters). Nous allons avoir la joie de baptiser la petite Jacqueline Lisa Owers-Leduc pendant cette célébration. La célébration sera aussi diffusée sur la toile informatique.
- Pour le regroupement *Saint-François*, le groupe va explorer le Chapitre 3 de « Thriving Churches » ensemble en avril. Le groupe continue le dialogue au tour de la construction d'un ministère collaboratif afin de répondre à la question d'insécurité alimentaire à travers la région du regroupement.

Étant donné qu'il y a une paroisse de l'Église Unie dans ce regroupement qui à une collaboration avec deux paroisses Presbytérienne, ce projet sera œcuménique. # Dialogue Judéo-Chrétien de grand Montréal

Le Dialogue Judéo-Chrétien de Grand Montréal a envoyé une lettre au Modérateur Richard Bott, au Secrétaire générale Michael Blair, ainsi qu'au conseil général, et à la Ministre Exécutif Rosemary Lambie et le Conseil régional Nakonha:ka Regional Council exprimant les inquiétudes qui soulèvent du rapport « Just Peace ». #### Strategies to encourage dialogue and connection

As we have experienced lately, one of our challenges as a regional council continues to be the promotion of healthy dialogue and relationship building: between leadership teams, between communities of faith, between regional council members, ministry personnel and staff.

I believe that the strength of our regional council lies in building more lateral connections, in a web of coherent communications and shared action, and a mindset of abundance versus scarcity. To that end, I am working on developing a new social media and newsletter strategy to include a series of questions that may lead readers to consider how they (as individuals, members of leadership teams or communities of faith) are being called to live their faith in connection with others, and to help us, as the executive leadership team, identify the strengths and needs of communities of faith in our regional council. Your input in creating thought-provoking and engaging questions would be extremely helpful.

Here are a few examples so far (with draft translations to be proofread before publishing):



## Strategies to streamline and focus communications

A shift back to more streamlined messaging in newsletter and social media will focus on simple visual reminders and crucial regional council content in a welcoming format, such as important reminders (see examples below) with some local, national and international content. I have been doing a lot of proactive work to seek out content from communities of faith and other sources online, but may be diverting some of that energy in future to gathering resources that will help communities of faith and leadership teams be more proactive in preparing and executing their own communications strategies at a regional level.
