V. Laurentien Area Ministry

Bryce) that the Conseil régional Nakonha:ka Regional Council Executive concurs with the recommendation of the Pastoral Relations Leadership Team to make an exception to the Ministry Personnel Involvement in a Former Community of Faith Policy which states, "After at least three years has passed, the former minister may return to their former community of faith after consulting with the incumbent minister and the Church Council/Board concerning expectations" until such time as a minister is appointed or called to this ministry. The exception is based upon the large geography for this ministry which includes 9 churches. Therefore, the recommendation is that Rev. Cathy Hamilton may attend worship in any of the communities of faith; and further, may lead worship not more than twice a month and in rotating locations to cover the nine points. This arrangement shall end with the call or appointment of a new minister.

Remuneration is based upon national church standards for daily pulpit supply and travel. **CARRIED**

Lambie) that the Conseil régional Nakonha:ka Regional Council Executive re-examine and reassess the structure of the Laurentian Area Ministry (LAM) organisation and review it from the point of view of financial continuity and the ability to provide ministry personnel services to that area. A joint working group between Pastoral Relation and Property and Finance, in full consultation with LAM, will conduct the reassessment. **CARRIED**

a) Policy Regarding Proceeds from the Sale of Property – A first meeting has taken place with good exchange; discussions will continue with the hope if recommendations coming in the fall – conversation may take longer.

b) Mid-Laurentian United Church

- Sale Agreement with Mid-Laurentian United Church (MLUC) for the sale of its Property to the Finance & Extension Board of Conseil régional Nakonha:ka Regional Council (F&E) – 2022, see **Appendix C**.

2022-06-15_012 MOTION (F. Braman/P. Bisset) Resolved that Conseil régional Nakonha:ka Regional Council accept the recommendation of its Property & Finance Leadership Team that the Regional Council concurs with the request of the Congregation and Trustees of Mid-Laurentian United Church to sell their land and building in Rawdon, QC, except for the cemetery portion, and accordingly authorizes the transfer to the Finance and Extension Board in accordance with a Sale Agreement (annexed hereto) which also provides a Plan of Distribution including the Regional Policy on Use of Proceeds and further authorizes the signature of such agreement on behalf of the Regional Council by the Chair of the Property & Finance Leadership Team. The Property & Finance Leadership Team is further authorized to give any further approvals to facilitate the carrying out of this resolution. **CARRIED**

c) Trinity United Church, Cookshire

Oil leak: There has been an oil leak at Trinity United Church in Cookshire and the claim is being investigated. In the fall of 2022 an attempt to learn which churches (rural or urban) have oil reservoirs, in order to refit, or change, to avoid potential environment dangers and/or fines ensuing from leaking reservoirs will be undertaken.

4. Granting and Enabling Leadership Team – Rev. Barbara Bryce submitted a report, see Appendix D

Nurturing Social Justice and Outreach programs

5. Indigenous Ministry – Robert Patton reported on his gathering and the time spent sharing and growing relationships with groups across the Church. There is still much pain and grief existing from the history of First Nations Peoples and the Government of Canada (i.e. The Indian Act, amongst other atrocities).

Discussion: a) a 'distance' version of the Blanket Exercise is available on the Kairos website – suggested that the Living into Right Relations Leadership Circle consult with it when considering organising the exercise for the Regional Council;

- b) a means for funding has been created to accept monies to help support Living into Right Relations;
- c) more funding to help with the translation of the Bible into Mohawk from the UCC Foundation was encouraged by Royal Orr.
- d) Summerlea United Church will be donating to the Language Nest in Kahnawake.
- e) Recently the issue of Land Acknowledgment has been debated; should it be continued? The concern is that society is developing a 'good conscience' but is action getting done to accomplish change?
- **6.** Community of Faith/ Clusters/Networks David Roger Gagnon submitted a report, see Appendix E¹ and E².

Discussion: background information was provided on Me Richard Marceau (he is the Vice-president of External Affairs and General Counsel for the Centre for Israel and Jewish Affaires).

David-Roger Gagnon will work with Judy Coffin to update the list of membership to clusters and networks (it was noted that many lay people were not represented in the current list).

- 7. **First Third Ministry Ministères Jeunesses** Shanna Bernier provided an update re Spirit Camp, there are currently 45 campers registered. This year, almost half of campers have never attended a sleep away camp. Funds were available for campers (due to generosity of donations), no one was turned away due to not being able to afford attending. Finding camp counselors this year did not pose a struggle.
- **8.** La Table Rev. Marie-Claude Manga sent regrets, Rev. Samuel V. Dansokho shared a report, see as **Appendix F**.

Discussion: It was noted that Staff of four Regional Councils, which include communities of faith in Quebec, will also have to assess any impact Bill 96 has on communication with employees, etc.

Appendix A

Governance Structure for Greenfield Park United Church

Our mandate is to combine committees with duplicate members so we can focus our resources to keep our church being the vibrant part of the community of faith.

We have studied the Handbook *Models of Board Governance*, August 2010, and have decided to call our model **The Church Board.**

Note: The governing body may take any shape the congregation or pastoral charge chooses. When the congregation or pastoral charge has decided on its governance model, it must seek regional council approval. From Section B.7.2.1, UCC Manual.

The Church Board will meet a minimum of four times per year.

Church Board Members:

- Chairperson
- Secretary
- Minister
- Regional Council Representative
- Corresponding member of the Ministry and Personnel Committee
- Board of Trustees/Finance
- United Church Women Representative
- Worship Committee Representative
- Rental Manager
- Nomination Committee

Up to 10 **additional members** can be elected at large and could be responsible for the transportation or other special projects taken on by the church. These members can also be part of another committee.

All members of the Church Board will be elected each year at our congregational meeting, and they will all be considered **Elders.** Note: An **Elder** is a person elected by the pastoral charge entrusted with leadership. Members of the Worship Committee will be considered **Pastoral Care Elders.**

Ministry and Personnel Committee

This committee is responsible for the oversight and support of salaried staff and any complaints or inquiries the congregants may have concerning the salaried employees of the church. This includes people receiving honorariums from this pastoral charge. This committee is required in all governing models of the United Church of Canada and is strictly confidential. They will appoint a representative to attend Church Board Meetings.

Board of Trustees/Finance-

These elected members are responsible for all the property for the use and benefit of the congregation on behalf of the United Church of Canada.

They will also be responsible for all the Finances of the church with the exception of the UCW and the Benevolent.

A member will be chosen amongst them to act as Treasurer and will administer all the funds with the exception of those already listed. The Trustees/Finance will prepare a yearly budget. These tasks can be divided amongst the group. The treasurer will present a statement of accounts at each Church Board meeting.

Minimum of 3 and maximum of 15 members.

United Church Women

This committee remains as it always has been allowing them to function in the manner that works for them. There will be a representative chosen amongst the group who will attend the Church Board meetings. They will manage their own finances and report directly to the Church Board.

There are no minimum or maximum members required.

Worship Committee

This committee will be similar to the session but will **include all aspects** of worship as well as Christian education, choir, memorial requests, pastoral care, and pulpit supply.

All requests for funds to outreach programs decided by the worship committee, including memorial plaques, will be filtered through the Treasurer of the Church Board. There will no longer be individual accounts for choir, memorial fund, and Christian education. The only fund which is strictly confidential and remains at the discretion of the Minister is the benevolent fund. The group will nominate a representative for the Church Board meetings yearly.

There are no minimum or maximum members required for this committee.

Rental Manager

Is responsible for the rental groups who use our facilities and negotiates rental agreements and acts as a liaison between the rental groups and the **Church Board**. This person or persons will seek approval from the Church Board Chair or Worship Committee Representative before any agreement is made with any outside organizations.

Nomination Committee

The nomination committee will be comprised of each member of the **Church Board**, with the exception of the minister, under the direction of the Chair person and members will be elected annually at our congregational meeting.

Appendix C

<u>Sale Agreement with Mid-Laurentian United Church (MLUC) for the sale of its Property to the Finance & Extension Board of Conseil régional Nakonha:ka Regional Council (F&E) – 2022</u>

- 1. This Agreement is for the transfer by MLUC to F & E of the Church Portion of the real estate (Property) of MLUC located at 3253, 4th Avenue in Rawdon, QC, J0K 1S0, being Lot 5,785,495 of the Cadastre du Québec, consisting of both the Church and hall building and parking lot (Church Portion).
- 2. Prior to the transfer, the aforementioned lot will be subdivided so that the adjacent Cemetery lot (including the \$100,000 Cemetery fund held by MLUC for the Cemetery's upkeep known as the Cemetery Trust), will be entirely in a separate lot and continue to be owned by MLUC under the management of the Trustees of MLUC. MLUC is authorized to proceed to explore the establishment of an independent corporation to assume ownership and management of the cemetery following Québec legal requirements concerning such cemeteries. Regional Council approval will be required prior to the sale of the cemetery to such independent corporation or any other transferee. If the prior subdivision would unduly delay a sale of the Church Portion, another legal method to assure that the Cemetery lot remains under full church control pending full subdivision may be implemented with approval of the Property & Finance Leadership Team of Regional Council.
- 3. Sub-division costs including any municipal park contribution (approx. 10 % of area or value), survey, permits etc will be assumed by MLUC. F&E agrees to manage the process of subdivision if so desired by MLUC.
- 4. The transfer of the Church Portion (a separate subdivided lot) will be recorded by notarial deed to be signed and registered and will transfer absolute ownership to F & E.
- 5. The transfer is solely to allow F & E to effect the sale of the Church Portion in an orderly fashion.
- 6. The Net Proceeds of sale shall be split in accordance with the Regional Council Policy on the Use of Net Proceeds in force at the time of sale (currently 10 % to the United Church for indigenous ministries, 10% to F & E for the Regional Council's Strategic Ministries Fund and 5 % to the Mission and Service Fund (after payment of 2% up to \$5000 to the Archives Fund) with the remainder (about 75%) to be remitted to the Trustees of MLUC for investment and subject to limited annual distribution (the higher of \$50,000 or 8% unless a higher limit is agreed with the Regional Council).
- 7. The sale process is entirely in the hands of F & E, including sale price, terms, choice of agent etc., and all F & E's costs and expenses, including insurance, notarial fees, commissions, survey etc, shall be refunded from the sale price.
- 8. Although F & E shall have a free hand in the marketing of the Church Portion, it has agreed to consult with MLUC's Board about possibly offering a right of first refusal (maximum 30 days) to a very limited number of potential buyers for the market value as determined by an independent appraisal to be commissioned by F & E, before F & E has engaged a real estate agent (avoiding the cost of commission).
- 9. MLUC has agreed to continue to look after the security, oversight and care of the building (expenses charged to F & E) subject to its right to terminate this arrangement on reasonable notice (30 days). MLUC shall as instructed by F & E fully cooperate with the sale process in all reasonable ways so as to reduce expenses.
- 10. If possible F & E will attempt to have the future Buyer of the Church Property commit to offering MLUC rental space for one year terms, renewable and agrees annually for at least 5 years, but the parties recognize that this is subject to the Buyer's needs for the Church Property.

- 11. MLUC's Board shall identify any contents of the Church Portion not to be included in any sale prior to the transfer to F & E and agrees to remove these contents prior to the agreed upon occupancy date.
- 12. The Conseil régional Nakonha:ka Regional Council has approved this Agreement.
- 13. The parties shall fully cooperate with each other to assure to the smooth transfer and sale of the Church Portion and achieve the best transaction, both to respect the past traditions of MLUC and for the continued ministry of MLUC.

Appendix D

Granting and Enabling Report

While almost all of the applications that the Granting and Enabling Leadership Team received were reviewed and recommendations made to the Regional Councill meeting of June 4, 2022, there was one application that we lacked sufficient information to make a decision. This was an application from Eglise St Jean in Montreal from either the Kelley Fund or the Trois-Rivieres Fund for \$4000 for a project for integrating into the Quartier. A commission was formed of Barbara Bryce (chair), Darla Sloan, and Rick Sheffer. After Darla had contacted a member of the congregation the commission met by Zoom and is unable to recommend the grant at this time. It does not fit the parameters of the Kelley Fund and we find that there is more work to be done before funding can be made available.

Due to changes in pastoral relations, a new trustee is needed for the Erskine-American-Mountainside Trust and the EAM trustees are recommending through GELT the Rev. Youngho Jang as a new Trustee, effective July 1,2022.

We note that there have been a number of changes in the membership of our Leadership team, with the Rev. Ryan Fea and the Rev. Shaun Fryday leaving the region and Mr Peter Bisset resigning from the team. We thank them all for their faithful work over the last years.
