Rev. Kent Chown provided instructions for how the meeting format (in person and on Zoom) would interact with each other during the day. Rev. Steven Gillam welcomed all in attendance and provided housekeeping details (bathrooms, emergency exits, lunch, etc.).

Welcome to the land

Satewas Harvey Gabriel welcomed participants to Mohawk territory and also provided an updated on the translation project of the bible into Mohawk.

Settlers Acknowledgement of Land

Rev. Linda Buchanan, President, and Chair of the meeting, acknowledged her own settler-roots on this land, and gave thanks to the Mohawk Peoples for its stewardship throughout the millennia. Linda called for The United Church of Canada's continued work towards truth and reconciliation, and right relations with all First Nations Peoples, and its support for dismantling the doctrine of discovery.

Sosan Montour (from Kahnawake Community) led the Ohenton Kariwatekwen (Thanksgiving Prayer).

Presentation on theme: Daring Justice

Lisa Byer-de Wever, Co-chair of Living into Right Relations Leadership Circle, shared a presentation as a teaching on the theme of this meeting 'Daring Justice'. Jim Christie - Gatherings for 2025 in Honor of the 100th Year Anniversary of The United Church of Canada

With the permission of the President, the Rev. Dr. James Christie, VAM/SJUC, and Ambassdor-at-Large, Canadian Multi-faith Federation, extended greetings from Wood Lake Press to the Council, and highlighted the first of two publications dedicated to the 100th. Anniversary of the UCC. Both books, the recently released, Keys of the Kindom and the forthcoming The Untied Church of Canada spring from the creative and collaborative genius of the Rev. Dr. Brian Brown. (Dr. Christie distributed 10 complimentary copies from Woodlake to Council members.)

Conjoined, the two books might be regarded as a Back to the Future reflection on the UCC. At 100, critical reflection will be a necessity in advance of June 25th., 2025. But Brown and his team remain convinced that there is much to be celebrated, and a prophetic future for the UCC in the next 100 years. To that end, he draws from our rich and sometimes complicated heritage to reflect on past achievements, our transformed and transforming present, and a secure and faithful discipleship to Christ as the years unfold.

Dr. Christie noted especially in "Keys", the section addressing the establishment of the Canadian Multi-faith Federation, Sisters of Zion, SJUC Commemorative Library. The books and documents have arrived; the physical installation is underway, and this large, comprehensive world class library may be understood to be hosted by Nakon'ha'ka Region, and stewarded by SJUC.

Also on behalf of Woodlake and Dr. Brown, Ambassador Christie noted the sponsorship by Woodlake of televised cross-Canada liturgical celebrations in a number of Canadian cities, culminating on June 10, 1925 at SJUC. The intent is to draw other congregations and Mission Units in our region to participate in the planning and execution of these liturgical expressions.

Provisionally, Dr. Christie is happy to begin building a partnership, with all who wish, welcome.
