# **Mohawk Bible Reading**

To recognize the completion of the Mohawk Bible project, Genesis 18: 1-15 (NIV) was read in French and displayed on screen in English and Mohawk. The intention was for it to be read in Mohawk but this was not possible in Satewas (Harvey) Gabriel's absence.

#### **Opening Worship**

Rev. Paula Kline opened with a meditation on 'all my relations'. Paula highlighted the celebration held in September for the completion of the translation of the Bible into Mohawk and shared a video showing some of the history of the project. Rev. Wendy Evans shared a reflection on how an attitude of 'all my relations' is taking form in a variety of relationships within the Church and beyond, and expanded on what it means to live into right relations. Wendy also shared a personal story for how the song "In this Great Turning we Shall Learn to lead in Love" impacted her. This song was shared by video.

## **Equity Support Team**

Shanna Bernier highlighted the members of the Equity Support Team (Rev. Tami Spires, Lisa Byer-de Wever and David-Roger Gagnon), and explained the team's role during this meeting. Participants were also invited to join the Regional Council's Equity Support Team if they felt they had an interest in sharing in the work of equity. Rev. Tami Spires highlighted to be mindful of micro-aggressions.

## Remit 1: Establishing an Autonomous National Indigenous Organization

Marc Grenon, President, highlighted that regarding Remit 1: Establishing an Autonomous National Indigenous Organization, a pastoral charge which does not vote by March 31<sup>st</sup>, their vote will be counted as a "no" vote. Participation is currently low, only 10% of pastoral charges across the country have submitted their vote.

# Introduction of New President of Ministries in French (La Table des ministères en français)

Rev. Dr. Emmanuel Tehindrazanarivelo introduced himself as the new President of Ministries in French (*LaTable des ministères en français*), sharing personal information about himself, and the aspirations the work of French ministries.

# Strategic Plan

Rev. Helen Hliaras, Chair, of VisionAction Working Group, thanked members of the working group for their work on completing the regional council's strategic plan. Helen shared details about the various consultations that took place, and reiterated that the strategic plan's motivation was in response to The United Church of Canada's Call and Vision. The strategic plan was shared with delegates, and following its presentation, David-Roger Gagnon sang "With our Fish and Loaves of Bread / De nos pains et nos poisons" (arranged and written by David-Roger). Helen answered questions raised, and then the meeting separated into discussion groups. The following questions were posed:

- 1. Do you think this is a suitable plan?
- 2. Is there anything missing?

3. In what aspect would you see yourself becoming involved?

The following comments were shared following discussions:

- Positive and supportive reaction; appreciated focus on rural congregations.
- Hopeful image of the church within the Reginal council.
- Are there too many things trying to be addressed?
- Some experienced that the plan wasn't clear and was vague; nonetheless there was hope in resources being promised; and there was hope that rural congregations would not me left behind.
- Institutions rules can get in the way; hopefully, there is room for certain rules to get out of the way.
- Need to really listen to where the Spirit is leading; and not hinder it by focusing on institutional rules. As it is more and more difficult to talk about faith and why it is valuable; is the church prepared to share its theological proposition into the current climate of our culture. This may be a good time to hone the Church's theological presentation of Faith.
- Important not to get too caught up in governance and church buildings, or lose sight of the importance of communications, first third ministries and United Church partners.
- Reminder to focus on how the United Church welcomes its newcomers, especially in the current climate of the country receiving many refugees and asylum-seekers.
- Importance of not only focusing on emerging congregations, but also existing congregations that are struggling, and how to better serve their needs.

Following receiving these comments, Helen again thanked the members of the working group, for their work throughout the process; it was a real team effort.

The question on the vote was called, but it was deemed to be called too early, not giving enough time for discussion. Therefore, the Parliamentarian cancelled the vote, so that more discussion could take place and there was room to move an amendment(s). No amendments were brought forward.

It was reiterated that the strategic plan is a living document that can be revised over time, as specified at the end of the document when it talks about 'next steps'. It was stated that, what is being presented is the plan of the regional council, and that communities of faith are not required to follow the strategic plan. Nonetheless, it is the hope that communities of faith will become inspired to participate.

# **Welcoming New-Comers**

## **Opening Devotions**

Adedeji Sunday Akintayo, led the opening devotions, which included a land acknowledgement; the call to worship; a moment of personal sharing from Ozioma Obijiofor on his experience of intercultural and integration into The United Church of Canada; an opening hymn "Greatest Lord" by artist Sinach (video presentation); scripture readings: John 16:33 and John 14:27; and reflection entitled "The Journey with Christ" provided by Adedeji Sunday Akintayo; and a closing hymn "Jehovah" by artist Sis. Gloria Oluchi/ Restoration Praise (video presentation).

# **Updates to Supervised Ministry Education**

Rev. Caroline Penhale, Office of Vocation Minister, presented updates to the process of Supervised Ministry Education. Her presentation highlighted 1. how candidates are formed for ministry; 2. forms of supervision in Supervised Minister; 3. the role of the community of faith connection; and 4. how a community of faith report evaluates candidates. Caroline emphasized that from now on, the Educational Supervisor must be appointed, and the Community of Faith Connection must already be trained before the supervised ministry education may begin.

Caroline shared that there are currently 4 registered Applicants to the Candidacy Pathway from this Regional Council, and that there are 7 active Candidates from this Regional Council, at various stages of the Candidacy Pathway. Candidates who were present during the meeting were invited to introduce themselves: Qian (Erika Leung) Liang (at Mount Royal United Church); Jessica Gauthier; Lisa Byer-de Wever, Diaconal stream, serving at Merging Waters United Church; Kelly Molloy, Designated Lay Ministry Program, serves Laurentian Area Ministries; Jean Phillippe, Église unie St-Pierre et Pinguet; Adedeji Sunday Akintayo; Bailey Eastwood; and Virginia Wallace (through the Atlantic Candidacy Board).

Rev. Cathy Hamilton thanked Rev. Caroline Penhale in her role as office of vocation minister and her support to the Candidacy Board. Members on the Candidacy Board from this Regional Council include: Rev. Cathy Hamilton, Co-Chair, Rev. Cynthia Reynolds, Rev. Read Sherman, Gary Tompkins.

Rev. Samuel Vauvert Dansokho, member of the General Council Executive, expressed gratitude to members on the Candidacy Board. He also shared a video "Chorale Saint-Michel; Comment ne pas te louer" as a way of honoring and celebrating the work being done through the candidacy board.

# **Theme Presentation - Strengthening Invitation**

Judy Coffin and David-Roger Gagnon shared some skits of ways newcomers are being welcomed on Sunday mornings at church services within the United Church (i.e., not having website, not having accurate information on the website, pouncing on new attendees with invitation to learn, participate, joint committees). Despite these welcoming examples having the best of intentions, Judy and David-Roger admitted that in most cases, they've fallen short leaving newcomers without a desire to return.

improve a churches welcome, the following ideas suggested: Audience, Brand, were Communication/Conversation (ABC):

- 1. Gain a better understanding of your 'audience': Who's already inside the circle? Who lives or works nearby in our neighborhoods? Who's not part of the circle? And why not? Where is God at work in the community around us?
- 2. Identify your 'brand' as a community of faith: What are your skills as a community of faith? What are your members' core values and passions? What needs are you particularly well equipped to meet? Who are your ambassadors? What relationships and partnerships do they have with the wider community?
- 3. Communicate and enter two-way dialogue: What issues and topics are relevant and meaningful to both parties? How do you encourage the back-and-forth that leads to trust and commitment on both sides? How do you create open doors and fluid pathways for this process to occur?

Judy and David-Roger highlighted that there would be an information session, as one of the activities streams outlined in the strategic plan, which would look at 1. how to equip local communities of faith to be more present in local media and 2. Share worship resources to strengthen the invitation for youth.

The following actions were suggested to be taken immediately by all communities of faith seeking to become more welcoming: Websites: take a look at another community of faith's website and see what works and what doesn't. Do you have an official reception team? Are there clear guidelines and training? Is there a local organization that might have common values or goals with your community of faith? Allow space for people to "Play to their strengths"!

I final skit was shared exemplifying a good way to welcome a newcomer to one's church.

A twenty minute discussion period was held for small groups to form and reflect on:

- 1. What are some eye-opening glimpses for your own community of faith today?
- 2. What resources would be useful?

# **Health Break**

A 10 minute health break was had by all.

#### **Nominations Leadership Team**

Rev. Linda Buchanan shared that the position of President-Elect remains vacant, but the hope is that a nominee will be brought forward in time of the annual general meeting in March 2024. Also, and in response to the strategic plan, the Nominations Leadership Team looks forward to partnering with those who have expressed interest in looking at the structure of the Executive, and bring any changes to the current structure that are deemed necessary.

# Rosemary Lambie Fund for Learning: Respecting our Indigenous Neighbours

Fred Braman introduced the 'Rosemary Lambie Fund for Learning: Respecting our Indigenous Neighbours' drawing people's attention to its terms of reference. The fund has been created in honor of Rev. Rosemary Lambie, Past-Regional Council Executive Minister, and Past-Executive Secretary of Montreal & Ottawa Conference, who has faithfully served The United Church of Canada for the past 41 years before entering retirement.

Rosemary shared her appreciation for the creation of this new fund in her honor, and highlighted some of the experiences leading to her desire for this fund that would contribute to local indigenous learning opportunities.

Lisa Byer-de Wever, Co-Chair of the Living into Right Relations Leadership Circle shared her excitement for the creation of this new fund and highlighted that this will be an extraordinary opportunity to build relationship with First Nations Peoples and move towards reconciliation in real an concrete ways.

**2023-11-24-25\_005 MOTION** (F. Braman/L. Byer-de Wever) RESOLVED that the Nakonha:ka Regional Council formally establish the "Rosemary Lambie Fund for Learning: Respecting our Indigenous Neighbours" in furtherance of the attached Terms of Reference as jointly developed by the Property and Finance Leadership Team and the Living into Right Relations Circle. **CARRIED UNANIMOUSLY** 

It was shared that an initial contribution of \$10,000 has been made to the fund which increases its amount to \$110,000.

## **Regional Council 2024 Budget**

Paul Stanfield, Regional Council Treasurer, shared the 2024 budget, highlighting revenues and expenses. A big change this year is the General Council Ministry Grants have been reduced from \$240,00 to \$180,000 (60,000 reduction)—due to a decrease in givings to the Mission & Service Fund. Interest on GICs produced \$19,600.

There weren't major changes to expenses in the budget, a 2% increase has been allotted to salaries, and a few small increases in operational costs. Mission Support expense will remain at \$505,000.

# Finance & Extension Board (F&E) 2024 Budget

Paul Stanfield, Regional Council Treasurer shared that the Finance & Extension Board can disburse 5% of the most recent 8 quarters of the endowment fund (\$14,000,000). Therefore, in 2024, this disbursement amount is up to \$724,600. A majority goes to grants to the Regional Council for Mission Support. The remaining amount contributes to regional council operational costs, F&E staff and operational costs, and sabbatical grants and bursaries. It was highlighted that the sabbatical fund is unique to this regional council, and the fund is greatly appreciated.

A request was made to provide a graph (in the future) showing how Mission and Service dollars are supporting Rural Ministries.

It was asked if there is a mechanism for a full review of The United Church of Canada's relation to congregations, and a method of accountability of the new structures that were instituted in 2019? The example was provided, in 2006, there was a 12-million-dollar campaign to boost The United Church of Canada's presence online and in social media, but it was unclear if an accountability for the campaign was ever produced. Considering this, there is now a concern that their will be no assessment of the impact of The United Church of Canada's restructuring on congregations. Therefore, GC 44 Commissioner should be encouraged to ask for a date as to when they can expect to receive this report. It was agreed that the Executive leadership would pursue the matter, requesting that a date be set for when a review will be made available, and a response to these concerns be followed up on at the March 2024 annual general meeting.

## **Accounting Software**

Brian Ruse, Finance and Office Administrator shared that accounting software was being made available to treasurers throughout the regional council at a reduced rate. An information session will take place on December 11<sup>th</sup> 7 PM. Brian provided some examples for how the software can be used. It was shared that the software is only available in English, but support is available in both English and French. Craig McAlpine highlighted many of the positive attributes of the software being offered and encouraged those interested to attend the information session.
