### Executive Minister

It's been such a pleasure for me to serve the Regional Council in 2023 in my new role of Regional Executive Minister.

What I have most appreciated about the work we've done over the last year has been the willingness of folks to try new things, innovate and explore and develop a cohesive and practical strategic plan to help us achieve some of our goals and set our priorities. Of my three Regional Councils, this one was the first out of the gate with energy and enthusiasm.

While building the strategic plan together was not an easy exercise, it did help us to focus our energy and find ways to make our ministry throughout the region stronger. Everything we've set out to do is in the interests of responding to God's call and ensuring that the health of our communities of faith is at the forefront of our work. There is no Regional Council without communities of faith. We do not have a ministry separate or apart from congregational and local expression of ministry. There is no us versus them... there is only us.

The Executive of the Regional Council has been steadily evolving towards what I call a 3-D model: direction, decision and discernment. A group of wise people who are committed to strengthening ministry in this region should be using their time in a way that assists us in seeing the bigger picture and orienting us. This does not mean that they no longer see reports, but these are provided as content for reading and absorbing, leaving room for broader questions that arise from the work we are engaged in.

We've also been given some attention to the growth aspect of our call. We've identified a few emerging communities of faith and are starting to put energy in those places where new ministry is appearing. We are also working with congregations who have a desire to meet the spiritual needs of the world around us in new ways.

What is clear to me is that we cannot do what we've always done and expect different results. This does not mean that we abandon meeting the needs of those in our pews, nor does it mean that there isn't a need for traditional forms of ministry in the future, but we need to innovate and create energy around the significant spiritual needs of the world around us. Our context is crying out for our response and God is cajoling us into action by opening our eyes to it.

As we establish new ways to be church in the future, as we grow and evolve in the ways that our context teaches us, in the ways that God calls us, we will need to let go of some of the things we've cherished. This kind of transition is not easy. But we rejoice in remembering that we are not alone. Congregations may often feel alone in their struggles to figure out how to continue, and the Regional Council is the perfectly suited place to help them see their extended family in the faith, learn from one another and chart a new course where that is possible. Our Christian story is clear: death is not the end of the story. We are a resurrection people. Thanks be to God!

### Pastoral Relations Minister

The United Church of Canada's 2012 Statement on Ministry is a document which, 12 years later, we cite only occasionally. But I am attracted to the succinct way it, like our A Song of Faith, frames ministry in the Church of Jesus Christ as having two expressions: the Ministry of All, as all baptized believers are called to ministry; and Ministries of Leadership, for while all members share in the ministry of the Church, God calls some from within the community through specific gifts for ministry, including to paid accountable ministry. Pastoral relations is very much about supporting communities of faith and people in the ministry of all, ministries of lay leadership, and ordained, diaconal and designated lay ministries, to live out our call to Deep Spirituality, Bold Discipleship and Daring Justice.

I am conscious of the concluding words of the Statement on Ministry: "The church is about God's mission in the world. Therefore the Holy Spirit continually calls the church to renew its understanding of ministry, opening itself to new expressions that serve the needs of the present day." Our strategic plan guides the work of the Pastoral Relations Minister, and of the regional council as a whole, in responding to this call of the Spirit.

The goals set in the strategic plan can be met only by the working together of communities of faith (the ministry of all), lay leaders in the regional council and in congregations (ministries of leadership), and paid accountable ministers. So my work in 2023 emphasized several areas:

- serving and supporting communities of faith, particularly in the areas of pastoral relationships with ministry personnel, employment of lay staff, and other Ministry and Personnel matters;
- helping communities of faith to discern options as they live out their ministry;

- encouraging and supporting ministry personnel toward health, joy and excellence in ministry
  practice this particularly involves assistance with access to restorative care and in planning for
  retirement and transitions;
- supporting the Pastoral Relations Leadership Team, which is tasked with beginning and ending calls and appointments, recommending licensing for sacraments, and appointing regional liaisons and community of faith supervisors to assist communities of faith;
- liaising with my Office of Vocation counterparts, other staff in this and other regions, and the General Council Office;
- supporting the Regional Council and its decision-making bodies.

Among the highlights this past year were having six candidates in Supervised Ministry Education appointments in this regional council (I think this is the most ever); the approval by the regional council of a Sacraments Licensing Policy covering ordered and designated lay ministers in calls, appointments, and retirement; arranging training with two neighbouring regional councils for Ministry and Personnel Committees; assisting the Nakonha:ka Licenced Lay Worship Leaders with their initiative to establish contacts with LLWLs in other regional councils to share information in a national forum; putting in place funding for communities of faith which cannot afford to pay the expenses of their community of faith supervisors; and the inaugural retreat held in Châteauguay in September for ministry personnel and LLWLs, which will become an annual event.

In 2024 I am leading two of the activity streams set out in the regional council's strategic plan: Building and Strengthening Relationships with Communities of Faith, which will involve sending out visitor teams to share food, worship, listen and learn about the ministries and challenges of the community; and Invigorate Worship, which aims to refresh worship by creating showcases (a Deep Spirituality event in May, and "Then, Let Us Sing"/"Ensemble, chantons!" workshops in September) in which participants share creative worship elements. I see these two activities as important to realizing our call to Bold Discipleship, Daring Justice and Deep Spirituality.

As always, many people have been involved in making the day to day work of Pastoral Relations happen. I am thankful for the opportunity to work with the Executive Minister and all of my colleagues on staff in the regional council, nationally and in the Office of Vocation, the Pastoral Relations Leadership Team, the Regional Council Executive, La Table des ministères en français, regional liaisons and community of faith supervisors, and ministry personnel and lay leaders. I am grateful that so many people across this regional council, in all kinds of ministries, entrust their questions and stories to me as I hear of ongoing change and renewal in the church bringing both anxiety and anticipation.

### Minister Supporting Networks and Clusters

#### <u>An Overview</u>

While Covid-19 was still a consideration that shaped a number of our events in 2023, the opportunity to come together in person was a welcomed relief for many after the long period of physical distancing. While the Networks and Clusters work continued, a new and major portion of my work for 2023 was establishing and supporting both the VisionAction strategic planning team and constructing and

facilitating the process of public consultations that led to the development of a Strategic Plan which was accepted at the November Regional Council meeting.

**The VisionAction** (Strategic Plan) **Task Group:** The VisionAction Task Group was struck to guide the Regional Council through the process of developing a Strategic Plan to help better focus our numerous efforts of ministry offerings. Working with the VisionAction team, I developed a public consultation process by which VisionAction was able to canvass various segments of the population served by the Regional Council. In all, 10 consultations were held both in-person and on-line to hear from the population groups on what priorities they felt we should focus as part of the Strategic Plan. The final draft of the proposed strategic plan was submitted to the Fall 2023 meeting of the Regional Council, at which time it was voted on and approved. The work in the VisionAction meetings, consultations, report writing, and presentations constituted a significant part of my workload for 2023. Given the numerous sections of the strategic plan as part of my over-all workload for 2024.

**The Environment Network**: Again this year, I have been supporting my team colleague, Judy Coffin, in trying to rebuild this network and defining the vision of where and how this work can be done in the Nakonha:ka context.

No one has stepped forward to take on a leadership role for this group, so Judy has continued to share information on Environmental efforts to those on the mailing list for this network. A shortage of volunteers presents significant challenges in advancing the work of this network.

**The Pride & Friends Network:** This Network has been dormant for most of 2023. I did send out numerous invitations to try and bring people together in order to plan a collective approach to the Nakonha:ka presence at Fierté-Montréal 2023. In the absence of a network, a rush of last-minute planning went into the participation by some of our Communities of Faith in a presence for Community Days and in the Défilé de la Fierté. There was agreement that there should be a collective effort to plan together in 2024. No one has stepped forward to take on the leadership of this group. Again here, a shortage of volunteers presents significant challenges in advancing the work of this network.

**The Living in Right Relations Leadership Circle:** This Leadership Circle continues in the shared-leadership model, and continues to give voice to issues of most concern to indigenous communities. The Leadership Circle Hired a part-time person to coordinate various resources and efforts in protests and social justice action events connected to Right Relations and justice with Indigenous Peoples.

**The Justice & Communities Leadership Team:** This Leadership Team has now revised its mandate and terms of reference, and continues to employ a shared leadership model. Numerous community partners continue to be part of the network connected to this Leadership Team and many ministry projects continue here and abroad. Here again, a lack of volunteers brings its significant share of challenges in helping this network to grow. It is hoped that the Justice Correspondents/Justice Disciples called for in the Strategic Plan will help to renew this network and build a team of people across the Regional Council who are interested in engaging in Social Justice work both locally and regionally.

**The Affirm United Process Team:** This Process Team was not able to meet often in 2023 due to a lack of people willing to take on leadership of this process. In addition, a great deal of my work time was seconded to the work of VisionAction, which did not allow me the time I had wished for to be able to devote to getting this process started. The process will eventually make space for people in the Rainbow Family to share their stories, hear from members about their concerns and questions, and learn together about ways in which our Regional Council can live into its vision of an inclusive church. Efforts will be made in Spring of 2024 to re-launch the process and seek out leaders to help this work move forward.

#### Cluster Work

We, as a denomination, tend to be congregationally-focused. While there is modest progress in some of the Clusters, the strong tendency towards individualism among our communities of faith can slow progress towards greater collaborating and sharing of resources. I continue to work with the clusters to encourage any effort that moves in a direction of greater cooperation, collaboration and shared resources.

#### Laurentian Area Ministry Cluster:

I meet regularly with the Cluster Council, and have been able to offer my participation in conversations with particular communities of faith within the Cluster. The cluster is using a faith development resource I created, called "*Digging Deeper*", as part of a reflection series in Lent 2024. I appreciate their offering to "test drive" the series in a cluster context. The geographical area covered by this cluster is significant.

#### The Saint Francis Cluster:

The cluster completed its work on "*Thriving Churches*", exploring one chapter at a time and discerning ways that each community of faith can enliven their ministries. The cluster has now successfully transitioned to its 4<sup>rd</sup> one-year leadership cycle, and has experienced some changes in ordered ministry personnel. The Lay members of the Steering Committee have identified a number of avenues for possible shared/collaborative ministry, including; different types of pastoral care and pastoral visitation ministries; building bridges with temporary immigrant workers; and food insecurity. The annual retreat, initially planned for January 2023, had to be postponed to March of 2024. A cluster website is now constructed, and communities of faith share information about news and up-coming events. This cluster has a part-time Coordinator/Administrator, who is an invaluable help and support to the work of the cluster. The geographical area covered by this cluster is significant.

#### West Island & Riverside Cluster:

This cluster continued its Shared Sunday worship on the 5<sup>th</sup> Sundays of the months in which they fall, with most communities of faith participating in at least one 5<sup>th</sup> Sunday worship. Each of the 5<sup>th</sup> Sundays that were part of this process were well attended with around 80-100 people participating each time both inperson and on-line. *ALL* of the Communities of Faith in this cluster participated in Shared Sunday Summer Worship in 2023, with each community hosting at least one shared worship through the Summer. Their use of a "common on-line calendar" has allowed all of the communities of faith to be aware of the ministry offerings at the different ministry sites. The West Island & Riverside United Church Website is up-and-running and is becoming an important touchstone for the communities in the Cluster. This Cluster will continue with the 5th Sunday Celebrations, and will do some cross-cluster programming throughout the year of 2024, in addition to Shared Summer Sunday Worship.

#### South Shore and Valleys Cluster:

This cluster continued its building efforts in 2023 and opted to aim for some shared on-line programming and occasional shared worship celebrations. Building on the first cluster-wide shared worship, *Sundae Sunday in 2022*, the communities of faith accepted the kind invitation of Robert Patton and the community at Kahnawà:ke for a cluster-wide shared worship at Kahnawà:ke in August of 2023. There were well over 80 people in attendance, and the worship was followed by a traditional feast at the Teepee, which is a welcome project coordinated by Robert's son Bob Patton. The cluster held its second on-line shared worship for New Year's Day which was very well attended and well received. The communities of faith continue to share information with each other and invitations are extended for various on-line programmes and in-person events. The geographical area covered by this cluster is significant.

#### Yamaska-Shefford Cluster:

The communities of faith in this cluster exploratory conversation have decided not to formalize a cluster relationship at this time. They have decided to continue gathering for Shared Sunday Worship on 5<sup>th</sup> Sundays, and will continue to assess further steps.

#### Missisquoi Conversations:

There are no new developments in the conversation to report at this time.

#### Downtown Montréal

The ministers held a meeting at the end of 2023. For the time being, there are no specific voiced intentions towards clustering.

#### **Retreat Planning**

The second in what is hoped will become an annual retreat "*For All Who Minister*" was held at Manoir D'Youville in late-September early October of 2023. With over 50 people in attendance, participants were treated to a buffet of workshops on a variety of different interest foci, as well as time to renew connections with each other, to worship, and to enjoy the beautiful settings at Manoir D'Youville. The retreat focused on ordered, diaconal, DLM and appointed ministries on the first day. The second day saw the LLWLs join for a day of co-learning and retreating, and the third day served as the Fall Enrichment Day for the LLWLs. The group was treated to a team of Music Ministers who facilitated worship and workshops as well. The Planning Team has already begun planning for the retreat this Fall, at Manoir D'Youville, on **25, 26, 27 October, 2024**.

#### Christian-Jewish Dialogue

Mountainside United Church hosted the 2023 Christian Commemoration of the Shoah at the Burk's Chapel. There are on-going conversations with downtown churches to find a longer-term home for the Lev Shul Synagogue community, and there are hopeful signs of a growing partnership with Lev Shul and one of our Communities of Faith.

#### Lay Licenced Worship Leaders

I participated in the Enrichment day in the Fall of 2023, which was part of the retreat "For All Who Minister", at Manoir D'Youville.

#### Participation in National Church Groups and Processes

#### Participation in Network & Cluster National Church Dialogues:

The national networks for both the Clusters focus and the Networks focus were put on hold for most of 2023.

I have met more regularly with my counterparts in the EOORC and ECORC Regional Councils who are responsible for Networks and Clusters, and that has been a great source of support and resource sharing.

# Co-facilitating the "*Re-imaging Church; Reclaiming Your Call*" Development Programme on United in Learning

A national working group, in which I have participated, has developed a 6-week initial development programme for members of the church who wish to step more fully into their role of people baptized into the collective ministry of the church. Grounded in our emergence from the Reform Tradition, the programme is geared to helping members explore different ways they can collaborate with ministers to expand the ministry capacity of their communities of faith in a *Ministry OF All*, "Each according to their gifts". I have also been solicited in a consultation for the building of a national church programme to train *Collaborative Ministry Teams* of Ordered Ministers and Lay Members to share and strengthen the ministry of our communities of faith. And in anticipation for the launch of this programme, I have been asked to recommend two communities of faith/cluster contexts in which Ministry Students entering their Supervised Ministry Education could serve in a context that works on a collaborative team ministry model.

#### Ensemble, Chantons! Then, Let Us Sing!

I have continued to consult with the national team in an effort to expand the French-language content of the collection which will be released next year in 2025 in time for the Centennial.

### Communications

Deep. Bold. Daring. These words from the Call and Vision of The United Church of Canada describe how communities of faith in our regional council are living their faith: through worship, through outreach, through imagining a future that doesn't look anything like the past. Publicly shared stories and images give witness to the ways in which the church still offers gifts to fulfill local, provincial, national and international needs, such as events and activities that gather people in community, feed bodies as well as souls, make safe space for the marginalized, offer ways of learning to live together more harmoniously and to take better care of ourselves, our neighbours and all of Creation.

Some of the most widely shared stories on our social media channels in 2023 included the launch of an interfaith, intercultural cookbook by seniors, conversations with black and diaconal ministers across the country, an environment-conscious bicycle "resurrection" event, resources about Remit 1, the publication and dedication of the Mohawk Bible, and many milestone achievements and anniversaries of individuals and communities of faith. Congratulations!

Giving witness to our gifts as a church is important, but good communication is also about listening deeply in order to engage in honest conversation and dialogue, and building trust and relationship. As we live into the new regional council strategic plan, we are focusing on priorities we heard through consultation with communities of faith and ministries throughout the regional council. Sometimes the plan will mean saying "no" to the ways in which we spent our time and resources in the past, and sometimes it will mean saying "yes" to ideas that seem scary or impossible at first. Some efforts will fail, and we will learn together, by telling our stories. Some efforts will succeed beyond our wildest dreams, and we will celebrate together, by telling our stories. And as we get better at sharing our truths, we will connect more authentically and deeply with those in the wider community who need what we have to offer. Deep spirituality. Bold discipleship. Daring justice.

One of our strategic objectives in 2024 will be to expand and deepen conversations with the nonchurchgoing public in Quebec through a series of focus groups. The focus groups will help us gain a clearer understanding of spiritual needs and perceptions of church, and offer resources to the regional council (and its members) that will assist us in developing targeted communications to raise awareness of who we are, what we believe and how that might connect the seekers out there with people, places and events that may meet those spiritual needs.

### 2023 Financial Review

In 2023 total revenue exceeded total expenses by a small margin. Although revenue has exceeded expenses during each of the five years since the inception of the Regional Council, this is not expected to be the case in 2024. In 2024 the GCO is reducing funding for Mission & Ministry by \$60,000, which results in a projected budget deficit of approximately \$64,000 for the year.

Fortunately, we have built up a reserve over the last five years, which will be used to fund the 2024 deficit. In 2023 this reserve was used, among other things, to fund the newly created Rosemary Lambie Fund, to provide emergency funding to COCLA following a fire, and to contribute to the costs of the Mohawk Bible project. Thanks to a grant from the Finance & Extension Board, we were able to provide Mission Support of \$505,000 to 12 different worthwhile organizations.

A Worship Leaders' Retreat was held for the first time in 2023 and is anticipated to become an annual event, which has been budgeted for. We provided grants to several communities of faith to facilitate the purchase of equipment to conduct hybrid worship services, although this program came to an end at the end of 2023. Funding for the Living into Right Relations Leadership Circle to conduct their activities has now been integrated into the budget, whereas previously they had to apply for grants annually.

We provided support to facilitate the work of church treasurers, which included offering discounts on the purchase of accounting software, a spreadsheet to create a customized calendar of tasks throughout the

year, available bookkeeping services, and two webinars: one on resources for treasurers and another on grants.

Looking forward, 2024 promises to be a challenging year financially. Many thanks to the dedicated members of the Property & Finance Leadership Team: Peter Bisset, Fred Braman, David Clinker, Craig McAlpine, Dave McCormack, Ted Rutherford, Rick Sheffer, Paul Stanfield, and Jim Vanstone.

### Finance and Extension Board - Executive Summary

The Finance and Extension Board (F&E Board) of the Conseil régionale *Nakonha:ka* Regional Council is duly Incorporated under the United Church of Canada. It remains the principal financing means for the development of communities of faith in the Region and has oversight of the investment portfolio being the principal provider of funding for mission support, sabbatical leave and bursary programs.

The F&E Board's 2023 Annual Report will be released in April 2024. No significant issues are anticipated.

#### **Investment Review**

The F&E Board manages the investment portfolios on behalf of the Nakonha:ka Region through Fiera Capital Management. The investment objectives are reviewed annually and Fiera Capital meets with the F&E Board on a frequent basis to review results. The portfolio generates significant funding for Mission Support and Governance in the Region. Currently, \$14.5 million of unrestricted funds are invested in the Fiera Capital Balanced Ethical Fund for this purpose. The management fee is 0.3%. In addition, funds are held on a restricted basis for Kelley Trust, Erskine American and others. The total amount under management by Fiera capital on behalf of the F&E Board is currently \$21.3 million.

#### Property Review

The Property Committee oversees and provides technical and project management assistance to those communities of faith seeking financial assistance for construction and maintenance projects involving their properties and buildings. As an incorporated body we hold and or sell church property on behalf of the Nakonha;ka Regional Council. The following projects were supported by the committee in 2023: St James United Church, Hudson Pastoral Charge, Reconstruction Cote Church, Mid-Laurentian United Church, Sale of Church, ITCR – Sale of Church, Trinity Cookshire – Consulting and Environmental remediation.

#### Loans to Churches

During the 2023 fiscal year, the F&E Board administered one supplemental loan to St James United Church. At year-end, the combined current loan balance is \$1,026,449 for outstanding loans to: a) Union United b) Trinity Cookshire, and c) St James United.

#### **Financial Assistance for Bursaries and Sabbaticals**


The Bursary Committee awarded 29 bursaries from the following: Hugh Duncan Bursary (15 awarded, \$2,000 each), I.F.E Bursary (11 awarded, \$800 each), and St. John's Hall Bursary (3 awarded, \$2,350 each).

In 2023, a total amount of \$42,870 from the Hugh Duncan Fund was made available for the Sabbatical Leave program. Rev. J. Mountain, Rev. D. Clinker, Rev. N. Whitehouse, Rev. Dr. E. Jones and Rev. R. Sherman all participated in sabbatical leave in 2023 and all took the opportunity to share their sabbatical stories at the year-end meeting of the F&E Board- truly one of the highlights of the year. The F&E Board recognizes the vital importance of sabbatical leave for Ministry personnel and encourages those who have not participated in this program to do so.

#### **Financial Review**

The audited financial statements for 2023 will be included in the F&E Board's 2023 Annual Report. The Review Engagement process is currently underway by the external accounting firm BCGO.

For 2024, the F&E Board has budgeted a total of \$725,300 in funding available to the F&E Board and Region 13. This year's funding includes a mission support rant of \$505.000, a supplemental grant of \$55,000 to Nakonha:ka Region for operations, funding for F&E Board staff \$33,000, funding for F&E Board operations for accounting and investment fees \$69000, and sabbaticals for ministers and student bursaries \$62500.



#### Strategy Discussions:

As the Model Trust deed and the F&E Board's Bylaws offer wide latitude in terms of financing, acquiring, holding, administering and disposing of property for the Nakonha:ka Region, the F&E Board continues to have a key role in the strategic plan moving forward. Over the fall period, F&E participated in the development of the overall regional strategy. Church property remains a high priority with many communities of faith struggling with high costs for property maintenance and operations and, in some cases, lack of personnel to deal with property matters. On an ongoing basis if church buildings are sold,

normally 10 % of all proceeds are invested in the Regional Strategic Fund for which the Terms of Reference have been approved. The Fund is held in the investment portfolio of the F&E Board.

A significant organizational change for both the Property and Finance Leadership Team and the F&E Board has been proposed. The proposal brings together these leadership teams to deal with property and finance matters in a more efficient and balanced manner. Approval for this delegation is expected and implementation to begin in early 2024.

In conclusion I would like to thank the members of the F&E Board for their dedication and excellent work done this past year.

### Office of Vocation

Greetings from your Vocational Minister, Rev. Caroline Penhale. Thank you for the invitation to share with Nakonha:ka Regional Council information about the ministry of the Office of Vocation in Quebec and East Ontario in 2023.

From January to June of 2023, I shared this role with the Rev. Lillian Roberts. Up until that time, I was focused on our Candidacy Pathway. In this capacity, I served and continue to serve as the staff resource for the Quebec and East Ontario Candidacy Board as it accompanies applicants and candidates discerning and preparing for ministry and I also connect regularly with candidates and applicants at various stages of their formation for ministry in The United Church of Canada.

In July of 2023, I assumed the full role of Vocational Minister for Quebec and East Ontario, therefore expanding my focus to include all the ministry personnel in terms of oversight and accountability across three regional councils Nakonha:ka, Eastern Ontario Outaouais Regional Council and East Central Ontario Regional Council. I work cooperatively with the Pastoral Relations Minister in each region, especially in establishing and monitoring Supervised Ministry Education appointments. I approve the requests of ministry personnel asking to be available for call or appointment, and I provide letters of good standing when needed. I am also available to candidates and ministry personnel who have questions and could use support, especially in matters related to their vocation or to policies of The United Church of Canada that impact ministry personnel and candidates.

The ministry of the Office of Vocation is supported by volunteers from Nakonha:ka Regional Council who serve on the Quebec and East Ontario Candidacy Board, the Admissions Board, the Board of Vocation and the Response and Remedial Committees. I am humbled and grateful for the work that these board members do for the benefit of all who seek to lead and serve in The United Church of Canada.

2023 was a busy year for the Quebec and East Ontario Candidacy Board, which met 8 times either to engage in the administrative work of the board or to interview applicants and candidates. Over the course of these meetings, the Candidacy Board worked very hard to conduct 44 interviews with applicants and candidates across its three regions; 12 of those interviews were with individuals from Nakonha:ka Regional Council.

Across the three regions served by the Quebec and East Ontario Candidacy Board, we received 11 applications to the Candidacy Pathway in 2023. Over half of the applications came from Francophones choosing to follow the Candidacy Pathway process in French. This highlights the need for more French ministry opportunities, in Quebec, and also in other areas in Canada.

As the United Church continues to live into its mission of "Deep Spirituality, Bold Discipleship and Daring Justice", the Office of Vocation continues its important work: to support effective, faithful and accountable ministry formation and leadership.

In the coming year, it is my intention to create more opportunities for applicants and candidates to connect with one another so as to share in the joys and challenges of the Candidacy Pathway. To that end, I have begun hosting monthly Zoom calls in French and in English for candidates in Quebec and East Ontario to get to know one another.

Finally, I wish to close with an invitation: please do not hesitate to contact me if you have questions about matters of accountability and oversight such the interpretation and application of the Workplace Discrimination Harassment and Violence Response Policy and the Sexual Misconduct Response Policy and Procedures; the requirements to remain in good standing, or anything pertaining to a candidate's journey through the Candidacy Pathway.

### Leadership Teams Nominations Leadership Team

The Nominations Leadership team is made up of the following: Linda Buchanan (chair), Tami Spires, Helen Hliaras, Erika Leung (joined January 2024), and Joel Miller (Staff).

We have held 5 meetings since March 2023. The first was on May 12th, which focused on preparing the nominations to the executive for the June General Meeting. At this meeting in June we were commissioned by the Regional Council to conduct a Nomination Review and Transformation. On July 5th 2023, the Nomination Team met on Zoom to discuss the parameters of this Review and Transformation. On September 14th 2023, the Nomination Team met to discuss next steps and to explore the progress of the Strategic Plan. At the November gathering of the Regional Council, the Strategic Plan was adopted and the Nomination Review and Transformation became part of this important project. With the extra boost of support from the Strategic Plan the Nomination Team held a meeting on January 16th 2024 to discuss the creation of a document to enable conversation with the RC Executive. The Nomination Team met again to approve the first draft of a discussion paper for the RC Executive. All 5 meetings were held on Zoom.

Over the next few months the Nomination Team will continue to work on the Nomination Review and Transformation. There is no consensus at this time concerning a way forward, but we are hopeful that the dialogues will continue and that they will be fruitful. The hope is to have a plan that all parties can agree upon in time to elect the 2024-2025 RC Executive.

The 2023-2024 Executive was approved by the gathered Regional Council on June 3rd 2023 at Plymouth Trinity United Church. The Nomination LT continues to receive updates from leadership Teams concerning their membership and leadership. No changes to the Executive have been made since June 2023.

The Nomination LT wishes to thank the Vision Action Committee that worked hard on the strategic Plan and who affirmed the needed Nomination Review and Transformation. We are also grateful for the extra guidance from the Reverend Eric Hebert Daly (Executive Minister) we are grateful for his participation in our meetings and for the knowledge and resources that he has shared. The Nomination LT welcomed Erika Leung (Student Minister) to the Team in January of 2024.

### Property & Finance Leadership Team (P&F)

This is the last Annual Report for P&F as it was disbanded in January 2024 when all P&F matters were delegated to the Finance and Extension Board pursuant to the new Policy on such Delegation.

P & F had two basic mandates to assist the Regional Council in:

- a) oversight of property matters involving Communities of Faith and the Regional Council, including amalgamations, regroupings and disbanding
- b) oversight of the financial resources of the Church within our bounds including assistance to communities of faith and the Budget and reporting of the Regional Council itself

#### Property 1 4 1

During 2023, P & F has actively dealt with a number of requests from various communities of faith regarding property matters, such as various sales of church buildings, manses and other property, renovation and construction/redevelopment proposals, leases and the like as well as proposals for the use of proceeds from dispositions. The Team has also dealt with requests to waive or transfer property rights from past disbandings not dealt with previously.

The Team also re-examined the Policy on the Proceeds of Sale of Property and has ongoing discussions with the Living into Right Relations team for a possible change to include support for local Indigenous initiatives.

The Team is also developing a close relationship with the UPRC (United Church Property Resource Corporation now Kindred Works) to coordinate planning of church site redevelopment where feasible and in the interest of the Community of Faith and the broader church.

During 2023, in applying the Policy on Use of Net Proceeds of Sale of Property, communities of faith in this Regional Council shared with the United Church of Canada for indigenous ministries, with the Mission and Service Fund and for the Regional Council's Granting and Enabling Strategic Fund, as well as for the Archives Fund.

#### <u>Finance</u>

The Team reviewed and approved various changes in loan agreements with communities of faith and continues its oversight of same. It managed the financial affairs of the Regional Council, subject to Executive approval. It submitted Budget 2024 and continues its close oversight of same and oversaw the preparation and approval of the Financial Statements for 2023.

The Team was also concerned about the impact of proposed changes to the Assessment formula by the National Office and successfully lobbied for some improvements in the formula. We also continued a program to help communities of faith dealing with significant increases, except for the part of the increase dealing with the size of endowment funds. These subsidies amounted to less than \$ 10,000 this year but this may increase in future years. For 2024 we intend to recommend on an "as-needed" basis where there the changes cause excessive burden on communities of faith.

#### Future Projects

The Team is concerned about the heavy increase in the burden on volunteer Treasurers and has worked on a program to allow communities of faith to access expertise for compliance with the various CRA, payroll, Statistics and financial statements rules on a chargeback basis (above a certain threshold). This should make it easier to recruit church volunteers who are not accounting experts. In addition it has been proactive in developing the Regional Council's response to the financial strain brought on by the pandemic and its effect on our various communities of faith and it particular has established a program of grants for hybrid worship equipment which ended on December 31, 2023.

- We are confident that F&E will continue the same policies going forward.
- We are always looking for ways to equip communities of faith better for this challenge.
- We continue measures to assure that environmental risks related to remaining heating oil tanks are managed, and if possible eliminated.

This is indeed a major change as involving F&E is an innovation after almost a 100 years but we are very confident that this will be a seamless transition for our ministries and communities of faith.

### Living in Right Relations Leadership Circle

Thanks to Creator it has been a consequential year for the work of our Circle (LIRR) and that of the wider Regional Council.

#### 1. Celebrating the Mohawk Bible

We are so grateful to our friend **Harvey Satewas Gabriel**, and thankful for Susan Gabriel, and everyone involved in seeing to completion the decades-long effort to finish the first complete translation into Mohawk of the Bible! In response to a need for more funds, LIRR launched a fundraising initiative that resulted in \$41,850 being received. We are grateful for the organizations and individuals who donated so generously.

September 9th many members of the Conseil Régional Nakonha:ka Regional Council had the privilege of attending the dedication service and launch of Mohawk Bible. Given the legacy of Canada's residential schools, the emotional and empowering significance of this history-making achievement was palpable; the celebratory service was very moving.





On October 1st, the Mohawk Bible was again celebrated at St. James United Church as they honoured the labour of Harvey Satewas Gabriel and the long history of friendship between the people of Kanesatake and St. James.

They also honoured the memory of Satewas' great grandfather - Onesakenarat, (Chief Joseph / Sosé), who had translated the Gospels into Mohawk -- by making a pilgrimage up to Mount Royal Cemetery to visit his grave.(Satewas at his great grandfather's grave.)

We were grateful for the generosity of our Regional Council at the initiative of the Property and Finance Leadership Team, and in consultation with LIRR, to approve \$10,000 toward purchase of copies of the Mohawk Bible to allow free distribution of copies to area Indigenous congregations, schools, etc., and a copy each to those Pastoral Charges which would agree to respect Indigenous people and walk with them in a good way into the future.

#### 2. Respect & Kanoronhkwátshera

With our funding from Conseil Régional Nakonha:ka Regional Council, the LIRR leadership circle was able to apply for and obtain a springtime "Seeds of Hope" matching grant from the United Church of Canada Foundation in order to hire a part time (10 hours/week) justice advocacy coordinator.

**Aviyah Abrams** began her 32 week contract on October 1, 2023 and began to familiarize herself with our hopes and intentions as well as educating herself in regards to Indigenous experience and concerns. She studied key documents and participated in the self-guided, online course, <u>Home on Native Land</u>, offered by Raven, while researching resources that will help us work for justice in harmony with the Original Peoples in our Region. The impressive results of her research and translation abilities can be seen in monthly <u>newsletters</u> for the Region and on our social media platforms, including the bi-lingual website that she has developed with the generous assistance of Judy Coffin. You can follow the link above and learn more about Respect & Kanoronhkwátshera. Aviyah has also begun reaching out to Indigenous and non-Indigenous advocacy and intervention organizations with the hope of establishing and/or strengthening our connections with them.

Our Creator engages us in the long, often slow work of building relationships of mutual trust and care. We would like to thank Conseil Régional Nakonha:ka for gifting us with funds to do our work and the United Church of Canada Foundation for entrusting us with a "Seeds of Hope" grant. We'd also like to thank these members of the amazing staff of our regional council who have helped us with their financial, technical, literary, and spiritual support: **Brian Ruse, Rev. Éric Hébert-Daly, Joel Miller, Judy Coffin, David-Roger Gagnon**, and **Rev. Dan Hayward**.

#### 3. Remit 1

LIRR members made a presentation at the June Regional Meeting in Sherbrooke to highlight the importance of a response to Remit 1, "Establishing an Autonomous National Indigenous Organization." This included videos featuring **Robert Patton** and **Alma Ransom** speaking about the importance of treaty and Remit 1 to recognize the Indigenous Church's right to autonomy within the United Church of Canada. The Region voted in favour of Remit 1. A record number of people attended informational webinars on October 4 (English) and October (French). Throughout autumn and winter Shanna, Fred, Christine-Marie, Read, Maureen, Jan L and Jan J, Lisa reached out and supported our communities of faith in hopes of them voting before the March 31 deadline. Thank you! By the end of February, 57% our region's CoF had voted.

#### 4. Rosemary Lambie Fund

This fund was initiated by the Property and Finance Leadership Team as a tribute to the long advocacy of the Reverend Rosemary Lambie upon her retirement as our Executive Minister. We were pleased to be asked to collaborate in the formation of the Terms of Reference for the fund, bringing the LIRR, Rosemary Lambie, and representatives of Kahnawake and Kanesatake United Churches together to envision how it could have the most impact in a good way. Initiated with \$100,000, it was agreed "the disbursement of funds annually is limited to the greater of a) 5% of the capital balance at the beginning of a given year and b) \$20,000" could be used each year to fund projects that "promote education, co-learning, and building right relationship so that we all might have a better understanding of the history and/or contemporary experiences and concerns of our Indigenous neighbours." LIRR encourages submissions to fund projects via the Rosemary Lambie Fund!

**5. Robert Patton recommended for ordination!** - After many years of study and discernment, Robert was recommended for ordination to serve Kahnawake United Church at the National Indigenous Spiritual Gathering held in Edmonton, July 27 through 30. Congratulations to Robert and the wonderful people he will serve! The service will be April 27, 2024.

**6. National Indigenous Spiritual Gathering -** Several folks from Nakonha:ka Regional Council attended the gathering, including **Robert Patton, Alma Ransom, Sosan Montour**, and **Rev. Jan Jorgensen**. About 150 people attended in all, engaging in worship, fellowship, discernment over many issues facing the indigenous community, including the national drug use and suicide crisis, missing children and unmarked burial sites, Remit 1, and business from the five Circles of the Indigenous Church.

#### 7. Kairos Blanket Exercise

The Kairos Blanket Exercise (KBE) continued to be a powerful experience for learning in 2023. It was also a year of transition. In the past, trained leaders (Indigenous and non-Indigenous) could partner with an Indigenous elder to offer the KBE, now it will be made available through an Indigenous entrepreneur who will act as guarantor for the experience that it is done accurately and has the best impact for all. An experiential tool for non-Indigenous to learn about the history of colonization in Canada and the loss of land and culture, the KBE can be a triggering experience for those who have lived through this loss. It has always been important to have an Indigenous elder present to be able to help process the learning after, including the feelings it brings up. LIRR looks forward to partnering with a local Indigenous entrepreneur who will work with us and others to continue to bring this learning to congregations, schools, and other settings.

#### 8. Nakonha:ka Regional Executive

2023 saw a transition in leadership on Executive from Robert Patton as LIRR representative to a co-lead team including Lisa Byer de-Wever, Jan Jorgensen and Read Sherman who take turns being present for the meetings. We are grateful for the Region allowing us to serve in this way. Robert had served on the Executive since it came into being and we are grateful for the insight he brought to this important table. It remains a challenge and opportunity! to learn to work together in good and humble ways. Our colonial ways of working can sometimes be triggering, leading to unintended pain and harm. LIRR remains committed to helping us learn to be together, to do the work of the church, in ways that encourage all to share their stories and gifts. We see this happening at the Executive level, and look forward to a deepening collegiality in 2024.

### First-Third Leadership Team

First-Third Ministry in the United Church serves the members of our communities who are in the first third of their lives: children, youth, and young adults. Nakonha:ka Regional Council's First-Third Ministry team strives to support, sustain and create programs which are designed for people who are in this distinct

phase of life. While working intergenerationally frequently enriches youth and young adult ministry, we feel that young people have specific needs which must be supported.

Our report focuses on the work we did in 2023, sub-divided into three sections: Children's Ministry, Youth Ministry, and Young Adult Ministry, acknowledging that sxeveral events support different groups or are intergenerational. We also provide support, training, and resources to leaders of children and youth, who are often volunteers in communities of faith.

#### Children's Ministry

St. Francis Cluster Messy Church - Intergenerational Community Worship

• Shanna supported four Messy Church events in Lennoxville, with volunteers and participants coming from numerous churches in the St. Francis region. Plans are underway for even more growth and development of this project in 2024.

United Spirit Camp

• There is a lot of overlap between the membership of this team and the camp committee. Although members of this team did much more than this for United Spirit Camp, they did so as members of the camp committee. This team mainly played a supporting role in promoting this one-week sleepaway United Church camp for 8 to 16-year-olds.

#### Sunday School / Children's Church Support

• Because many of the UCC's most popular Church school curricula (Seasons of the Spirit & Whole People of God) were discontinued in 2023, there were a lot of requests for support in this area. Shanna as staff support, as well as several members of the leadership team, researched alternatives. This year churches in our Regional Council are investigating the resources from the UCC's Go Project, Illustrated Ministries, The Salt Project and others. United Spirit Camp used the ecumenically developed "Inside Out - Christian Resources of Outdoor Ministries" curriculum in 2023, for their *Fruits of the Spirit* Camp week, and will be using it again for their upcoming camping season.

#### Youth Ministry

Youth Forums

- March 31-April 2, 2023 Trinity-Anjou United Church hosted, Wendy Evans guest speaker with the theme of "In our Element"
- November 3-5, 2023 Plymouth-Trinity United Church hosted Interfaith bridge building with Muslim Community & Workshop on Islamophobia with Dr. Christopher Stonebanks

United Spirit Camp

- June 25 to July 1, 65 campers, Spiritual Fruit Salad 12 youth & young adults worked as volunteer counsellors and staff at our week of camp. Several youths also sit on the Camp planning committee, to provide a youth perspective.
- Local youth groups exist in different communities across our region, and Shanna cannot participate in all of them. It is worth noting that if a Youth Group ever wishes to invite Shanna to come and present a workshop, or promote Camp or Youth Forum, that would be her pleasure! In the St. Francis area, Shanna leads a local Youth Group with participants aged 10-15. They typically meet on a Friday evening and play games and have been gathering monthly since the Spring of 2023.

#### Young Adult Ministry

- Young Adult Retreat September, 15-17, 2023
  - 25 participants between the ages of 20-35ish
  - Theme: How do we show up for ourselves? "Se prendre en main"

 Many young people struggle with balancing all of the demands that work, school, family, and the wider world place on us. We developed skills to care for ourselves, set healthy boundaries and find strong communities of support in a beautiful theological framework set out by our Worship leader Bailey Eastwood. It was a beautiful time of playing in nature, relaxation, and practical learning rooted in an affirming and open Christian community.

#### Leadership Training / Resource Development

- Anti-Racism Curriculum testing (Autumn 2023)
  - Plymouth Trinity and Ste Genevieve United Church participated in the testing of *I am a changemaker: teaching anti-racism with children* developed by Heather Beamish, Amy Crawford, Adele Halliday, Springwater Hester-Meawassige, and Ren Ito for 6 weeks in the Fall. Testers provided oral and written feedback via Zoom to help the development team produce the final version of this curriculum.
  - In general we felt that the curriculum was well written, but not designed for the environments where it was tested, because of our multicultural, multilingual and largely immigrant populations. We offered several suggestions for improvement, namely translation and diversifying the type of activities for different learners. The final version will be available for purchase through the UCRD later this spring.
- Research and development in making sanctuary spaces more inclusive
  - A reflection has begun about what makes our sanctuaries and other church spaces truly inclusive of all ages. The beginning of this reflection was shared in the Nakonha:ka Newsletter. In the coming year, we would like to widen the conversation and visit more churches to see what challenges our communities of faith face in this area and develop creative solutions.

### Licensed Lay Worship Leaders

It is hard to believe that it is time once again to prepare this summary for the Annual Report. But here we are! Although the pandemic is over, Covid is still alive and well in our communities, and continues to affect our lives and the way we gather and work together. The Licensed Lay Worship Leaders (LLWLs) Leadership Team continued to meet on Zoom in 2023 and this will be the method of gathering for the team into the future.

Our team has continued to meet regularly, providing ongoing support to the LLWLs, and as had been the tradition in the Quebec Sherbrooke area for many years, organizing twice-yearly enrichment days for the LLWLs in all areas of our region. The Nakonha:ka Regional Council Executive has now made these enrichment days compulsory for re-licensing.

At this time, the Nakonha:ka Region has 14 LLWLs, most living in the Quebec-Sherbrooke (QS) or the Montreal areas, but some living in the remote regions of Métis in the Gaspé or Chevery on the Lower North Shore. We now have two francophone Célébrantes Laïques as well. And two of the LLWLs have moved on and are studying to become ordered or designated lay ministers. The Leadership Team consists of Charlotte Griffith (chair), Rev. Lee Ann Hogle, Shirley Knutson, and Allan Marshall from the QS area, Valerie Nickson (secretary) and Norman Haslam from the Montreal area, and Brenda Lee Strickland from Chevery. All of the team other than Rev. Hogle are LLWLs, or retired LLWLs.

On April 29, 2023, a hybrid workshop was held at St. Paul's United Church in Magog. The timely morning theme was Truth and Reconciliation: Background Information for our On-going Research. Jean-François Lozier, curator of French North American history at the Canadian Museum of History and Professor of History at the University of Ottawa, shared with us the Indigenous experience of Christianity in Quebec in a Zoom presentation. He described in detail the first contacts between Indigenous peoples and French Catholic missionaries in 17th and 18th century Quebec, and compared their situation with the English Protestant missionary work in New England at the same period. We looked at elements of the Catholic liturgy that were popular with Indigenous peoples as well as the changing social context in 19th and 20th century Quebec, with the increase of Anglophone settlement, the arrival of English Methodist missionaries in Kanasatake and Kaknawake, and the rise of biological racism. A lot of information to process. The afternoon session was a check-in time, a sharing of how each of us is dealing with life and work and church commitments and challenges.

On September 29th, 30th and October 1st a three day retreat was held at the beautiful Manoir d'Youville in Chateauguary, and was organized by a planning team including Rev. Lee Ann Hogle, Valerie Nickson and David-Roger Gagnon. The 29th was a time for clergy only, the 30th was a day for clergy and the LLWLs to share time together, and the 1st was for the LLWLs. The location was lovely, the event was well planned and was very much appreciated by everyone who attended. The time on Saturday gave the LLWLs a chance to meet the ministers in the Region, and the time on Sunday gave them the opportunity to check-in with one another and offer each other support. The weekend was replete with good fellowship, uplifting music, and a powerful presentation about a disabled God.Some of the LLWLs would have liked to have had more time together with the clergy. The one negative comment – there were no chocolates on the tables. This retreat was in lieu of the usual fall enrichment day.

The 2024 spring enrichment day will be a hybrid event held at St. Paul's United Church in Magog on Saturday April 19th starting at 9:00 am. At this time, the morning learning session has not yet been decided. And a fall enrichment day will be held sometime in September or October, but a date and topic have not yet been chosen. Another retreat is in the planning phase, but when it will happen is not finalized yet. Making the LLWL enrichment days bilingual is a challenge for the leadership team moving forward.

Re-licensing of the LLWLs is done every two years, and it is required that each LLWL be interviewed and approved by an interviewing team to continue. All of the LLWLs wishing to continue will be interviewed this fall, sometime in September or October, in preparation for a covenanting service between the Region and the LLWLs at the Regional Council meeting in November.

As well, a support team for students studying to become LLWL's has been formed. It is made up of members of the LLWL Leadership Team (Shirley Knutson, Valerie Nickson, Norman Haslam, Rev. Lee Ann Hogle) and Rev. Janet Bisset. We currently have 3 students studying and will be interviewing them shortly. Identifying who is taking the online courses continues to be a challenge and this team is working to streamline the process.

As we carry on in 2024, as LLWLs, and as Christians, with all the unrest that surrounds us in Canada and around the world, may the words from the 2006 A Song of Faith give us comfort and hope

"As children of the Timeless One, our time-bound lives will find completion in the all-embracing Creator. In the meantime, we embrace the present, embodying hope, loving our enemies, caring for the earth, choosing life. Grateful for God's loving action, we cannot keep from singing."

### La Table French Ministries

The year 2023 was a year of change and upheaval for French Ministries (MIF).

- First, the return of Rev. Darla Sloan as Interim French Ministries Manager, then the arrival of Rev. Dr. Emmanuel Tehindrazanarivelo in the position, then Darla's return as MIF Program Assistant to rescue the incumbent's departure.
- The hiring of a Communications and Development coordinator has not only expanded the staff team, but also breathed new life into it.

We have noted the growth and dynamism of MIFs, which delights us as much as it shake us up and challenges us in many ways (welcome, hospitality, interculturality, living our faith and hope together, call and vision, just a few examples...) and at different levels (structural, relational, theological, spiritual, resources and governance, diversity...). Good relations and transparent communications between the different structures and personnel involved have enabled us to face the challenges together and continue to do so.

Some noteworthy activities:

- People of African Descent Month, international solidarity with Gaza-Israel and Iran, participation in the International Conference on Eco-citizenship and Climate Change in Montreal, retreats for emerging community staff at the Manoir d'Youville and MIF staff in Granby.
- Training courses for laypeople, either face-to-face, in the field in emerging communities, or online by the new director, increased registrations, creation and strengthening of links with theological and pastoral training centers in Canada and internationally, not forgetting the Liturgical Platform.
- The Youth Camp offered by Camino de Emaus, the monthly meetings on the first Tuesday of the month, the launch of MonCredo, the bimonthly Newsletter and our daily link, which goes out three times a week.
- Finally, meetings and conversations with leaders and new emerging faith communities, pastoral visits by the Responsable to Toronto, Winnipeg, Moncton, Quebec City, Sherbrooke, Drummondville, and other French-language ministries around Montreal.

#### For the year 2024

The encounters, conversations, pastoral visits, meetings, and activities of 2023 will continue. Some connections will be created, others strengthened. The question is how to meet the challenges together in the face of growth with limited resources. How to be creative and innovative together under the pressure of harvest time within the framework of our Manual, the Call and Vision, and the Strategic Plan: a very fine prospect for the year 2024 at the dawn of our Centenary and the other years to come.

The MIF General Meeting was held on February 24, and the retreat that will take place in April. The monthlong celebration of People of African Descent took place throughout February. A biannual retreat has been decided for the Staff Team, with a view to strengthening bonds of solidarity and assessing achievements and challenges. A youth meeting is planned, as well as a symposium on French Protestant theologies in Canada. We plan to structure theological reflections around an Institute which, together with the Dio, will constitute a center of formation and expression for French-speaking Protestants. For the year 2024, as for the others to come, the challenge is, how to bring us closer together and work in synergy with the various structures of our Church so that MIFs and Communities of Faith beyond, benefit as much as possible, share and make known our witness of faith and hope to the whole of the United Church, and rally around our common call and vision.

## **Outreach** Saint Columba House

Since 1917, Saint Columba House (SCH) has advocated for social justice and improved the quality of life for low-income and isolated residents in Pointe St. Charles and beyond. SCH operates as a Community Ministry of the United Church of Canada (UCC) and has received Mission Support Grants in 2023 and 2024, along with the long-term provision of a building by the UCC. This report highlights SCH's activities in 2023 and evolving initiatives in 2024.

Through its new vision "called by God, as disciples of Jesus, the United Church of Canada, seeks to be a bold, connected, evolving church of diverse, courageous, hope-filled communities, united in deep spirituality, inspiring worship, and daring justice." (UCC Strategic Plan 2023-25.) SCH as one of its community ministries, embraces this vision as we to seek to respond to "God's whole aching world." (UCC Strategic Plan 2023-25).

What did "God's whole aching world" look like in Pointe St. Charles in 2023? Pointe St. Charles has undergone significant changes in recent years, transitioning from a low-income community to one facing gentrification and growing income inequality. Housing disparities illustrate this shift. 33 percent of residents live in subsidized housing and 27 percent in condominiums, many expensive and newly built, representing extremes in affordability. The social fabric was strained as long-term residents faced displacement and disruption. A multi layered crisis of poverty, growing food insecurity, unaffordable and sub-standard housing, and social isolation remained - but became more hidden among increased affluence.

How did SCH respond? It remained a place of compassion, caring, and connection through its suite of intergenerational programming which comprised of food security, healthy child, and youth development and initiatives to reduce social isolation. In terms of food security, the SCH Community lunch program served 10,185 nutritious, hot meals to low-income residents and its "Meals on Wheels" Program prepared and delivered prepared five meals a week to 50 low-income isolated seniors who experience mobility or cognitive challenges.

Healthy child and youth development programming included an "Alternate School" to promote schoolreadiness in at-risk pre-school children, an after-school program for 36 elementary school children, and a high-quality summer day camp for 73 children, between the ages of 6 and 14, was offered at an exceptionally low cost to make it accessible to low-income families. Youth-focused initiatives like the "Lead, Exploration and Development Initiative" (LEAD) and the "Counselor in Training Program" fostered skills development and built resilience and self confidence among 14 English speaking youth.

Lastly, SCH lived out its mission "to foster an inclusive community for all, through education, compassion, and breaking isolation" which is based on the belief that every person is created in God's image and has inherent value and worth, by sponsoring the following programs:

- "Seniors Connection Project," which promotes social connection among 25 English-speaking older adults,
- "Hand in Hand", a welcoming day program for 16 adults with intellectual disabilities
- "Passe-Action" Program which welcomes 7 participants who experience significant mental health challenges and who are valuable members of our food security team.
- Women's Group a monthly dinner and discussion group to provide social connection

• Francization Program which offers free French courses to 20 newcomers to Quebec

2023 also saw the publication of "Our Stories and Reflections: Covid 19," which recounts how members of the seniors' program and SCH staff rose to the challenge of the pandemic.

SCH faces many pressing challenges in 2024; the cost-of-living crisis is causing widespread distress; it is also felt at an organizational level due to the ever-expanding cost of running a community-based non-profit. Despite these challenges, SCH continues to display "bold discipleship" as we seek creative and innovative responses "for such a time as this." (Ester 4:14 in UCC Strategic Plan 2023-2025.)

SCH is looking outwards in 2024 to explore new possibilities to strengthen our capacity to deliver our mission. SCH is strengthening its partnership with Concordia University Department of Play Therapy; we are seeking funding to integrate play therapy, a proven strategy to treat emotional trauma in children, into our children's programming. We are collaborating with the "Regroupement de Popotes Roulantes" to identify ways to streamline our meals on wheels production and delivery with the hope of expanding our service over time. Financial support from the Covid Recovery Fund will allow us to reach out to English speaking seniors to find new ways to respond to evolving needs. Lastly, we will reach out to United Church congregations to thank them for their generous support and explore new ways of working together.

### Colleges

# The United Church Studies Program at Montreal Diocesan Theological College

At Montreal Diocesan Theological College—widely known simply as Dio—we are now in our third year as an ecumenical institution following the integration of the United Theological College beginning in the 2021-2022 Academic Year. Our United Church Studies program remains strong and vibrant. We have a solid number of students at various stages of the candidacy process and are looking forward to welcoming several new ones in the fall. United Church worship is a regular part of our chapel life and we have welcomed several ministers from the Nakonha:ka Region to lead worship over the past year.

As we continue to deepen our integration as an ecumenical institution, we are renewing and expanding our programming. This includes:

- The Certificate in Bilingual Ministry Program and French for Ministry Intensive. In May 2023, we hosted the first in-person French for Ministry intensive week since the pandemic, taught by Clara Maranzano. It was a delightful week with an ecumenical student body, many of whom continue to meet online in an advanced discussion group centred on theology for ministry. The French for Ministry intensive is being offered again in May 2024.
- The Montreal Mission Internship. This program offers service-learning, vocational discernment, and theological reflection in community over nine weeks in the summer for young people ages 18 to 25. We had a successful offering in summer 2023 with several students from a United Church background and are looking forward to the 2024 iteration. Applications are being accepted through www.montrealmission.ca. Interns receive a stipend of \$5000 for the program.

- Online open enrollment courses. The college routinely offers short (three to six weeks) online courses designed for adult education and lay formation, in both English and French. Our offerings this year have included courses or workshops on preaching, Medical Assistance in Dying, the prophets of the Old Testament, and United Church history and theology. We welcome conversation with people in the Nakonha:ka Region about how we can offer courses that meet the needs of your community of faith.
- Learning Circle for Admission Ministers. In May 2023, we offered for the second year in a row a week-long intensive learning circle for admission ministers to the United Church. This was an excellent time of building inter-cultural community, introducing newcomers to the church, and looking to the future of the church with hope. We will be offering a variation of this again in May 2024. It will be a 4-day course taught in French and focused on introducing (or re-introducing) the United Church through the lens of Canada's inter-cultural reality. All are welcome as you don't need to be an admission minister to join.

It is programmatic fruits like these that are the most compelling proof of our success as an integrated college to date. But part of the reason for considering integration was financial realities. While we still have work to do, it is good to report that the integration of our colleges has led to a position of much greater financial stability. We continue to be immensely grateful for the dedicated and faithful financial support of our ministry from so many people.

Just as the church is changing, so are we. After many, many years of faithful service, the Rev. Dr. Alyson Huntly will be retiring at the end of May. We are currently searching for her replacement. We are also currently looking at how we can respond to changes in theological education prompted by the end of the Designated Lay Ministry Program, as well as how we can support French-language programs that lead to testamur for ordered ministry.

Our ecumenical Board of Governors is currently engaged in our first strategic planning process as an integrated institution. We see tremendous possibility for our ministry from our base in a multi-cultural and bi- and multi-lingual city to support the United Church of Canada as we move forward at a time of great change to realize the strategic objectives set before the church and be a people of Christ's kingdom of justice and peace.

Whereas there is currently no obvious national consultative body for the LLWL Leadership Team to refer to for LLWL's such as the Office of Vocation for ordained ministers,

Whereas the LLWL Leadership Team has no way of knowing which students are currently enrolled in the online course

Therefore; the following addition be made to the current Regional Council Governance handbook p. 42

1. Police Records Check The LLWL Leadership Team are required to exercise due diligence by requesting to see a Police Records Check (Vulnerable Sector) issued within the past 6 months before recommending granting initial license, and every 6 years subsequently. Licensed Lay Worship Leaders are expected to meet the same standard as Ministry Personnel. <u>http://www.united-church.ca/files/handbooks/police-records-checks.pdf</u>. Failure to provide a current Police Check at the appropriate intervals will result in non-renewal of one's license. *Addition: In the case of a Police Records Check (Vulnerable Sector) that turns up a conviction, the process outlined in the Police Records Check (2019) document will be followed.* 

If the LLWL Leadership Team nevertheless recommends licensing, certain convictions would require publication of the past offender's name and conviction and greater ongoing supervision may be required (e.g. violent crimes such as murder, assault, abduction). This would take place at the time of licensing. In the case of someone training to become an LLWL, the student may wish to request an initial discussion regarding their past criminal record prior to the 6-month requirement, in order to ascertain if their offense would be an impediment to licensing.

- 2. While deliberating on the suitability and guidelines required of a student with a criminal record the LLWL Leadership Team will avail themselves of the legal counsel of the United Church General Council, and consult with the authorities in matters of Restorative Justice.
- 3. A network be set up across all Regional Councils, comprised of all Licensed Lay Worship Leaders Leadership Teams, the purpose of which would be to share policy and best practices in licensing and supporting our Lay Worship Leaders.
- Each Regional Council LLWL Leadership Team be informed of all students from their region who are currently enrolled in the online training course sponsored by Canadian Shield Regional Council, the better to offer local support and periodic local evaluations in preparation for eventual licensing (adopted by the Executive on October 20). Since Hudson Pastoral Charge has already worked with EDGE for the development of a new ministry plan, and since the amounts of its endowments after the redevelopment, inclusive of its housing allowance fund, are expected to be less than \$500,000, the Trustees of Hudson Pastoral Charge have full discretion, subject to United Church Trustee guidelines, with respect to the disbursement of such funds after the redevelopment.

# The Rules of Debate and Order

### **1. Presiding Officer**

The function of the Presiding Officer is to preside, with all that that implies. The Presiding Officer should not attempt to control the decision of the Court, but may express opinions on any matter before the Court. If the Presiding Officer wishes to introduce a motion or to present a report, the Presiding Officer shall ask another member to preside, and while out of the Chair shall be an ordinary member of the Court and must not assume the chair until the matter is disposed of. The Presiding Officer does not vote except in the event of a tie.

### 2. Questions of Privilege and Order

(a) A point of order may be raised while a matter is pending or while another member has the floor. When a point of order is raised it must be dealt with by the Presiding Officer without debate. If a member has the floor when a point of order is raised by another member, that member must yield the floor until the Presiding Officer has made a ruling.

(b) Any member of the Court may appeal from a ruling of the Chair, but only at the time when the ruling is made. But where a ruling is a precedent the general question of its correctness may be brought up later when there is no business pending, but cannot then affect the business transacted under the ruling.

(c) When an appeal from a ruling is made, the Presiding Officer should state the point at issue, and may give reasons for the ruling. The Secretary shall then put the question in the following form: "Is the ruling of the Moderator (or such other title by which the Presiding Officer is known) sustained?" If the vote is a tie, the Presiding Officer is sustained. The Secretary shall declare the result.

### 3. Orders of the Day

(a) When an agenda has been adopted that does not specify the time for its items, such items are considered without time limit, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting.

**(b)** When an agenda has been adopted that specifies the time for particular items, such time shall be strictly adhered to, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting.(2010)

### 4. Order of Priority on Motions

- (a) To close.(2010)
- (b) To fix the time to adjourn.

(c) To adjourn.

- (d) To take an immediate vote (two-thirds (2/3) vote required).
- (e) To limit or extend limits of debate (two-thirds (2/3) vote required).
- (f) To postpone definitely.
- (g) To commit or refer.
- (h) To amend.
- (i) To postpone indefinitely.
- (j) To deal with main motions.

### 5. Procedures on Motion

(a) A member of the Court proposes a motion.

(b) It is seconded. If there is no seconder, the motion fails.

(c) When the motion is duly moved and seconded, the Presiding Officer states the motion and declares it open for discussion. If the mover has not already done so, the mover has the right to introduce the discussion.

(d) A motion is out of order when it conflicts with a resolution previously passed at the same session unless it is a motion to reconsider.

(e) Without the permission of the Court, no member may speak more than once on any motion or on any amendment thereto.

(f) The mover of a motion has the right of reply before any vote is taken thereon or on any amendment thereto. Even when the Court has directed that an immediate vote be taken on a motion, the mover still has the right of reply.

(g) When a motion has two (2) or more clearly defined parts or points of issue, and any two (2) members request that it be divided, a separate vote must be taken on each part.

(h) Any motion may be withdrawn but only with the consent of its mover and seconder.

(i) After a motion is under consideration a question of order cannot be raised against it unless the motion is ultra vires.

### 6. Procedure on Amendments

(a) Any member except the mover or the seconder of the motion may move a relevant amendment thereto.

(b) An amendment must be seconded, and if there is no seconder it fails.

(c) A motion is amended by striking out certain words or clauses, adding certain words or clauses, or striking out all after the word "Resolved" (or the word "that"), and inserting another motion that will dispose of the matter. An amendment that merely negatives a motion before the Court is out of order.

(d) There may be an amendment to the amendment, provided it has been duly seconded.

(e) There is no limit to the number of amendments, but at any one time there can be before the Court only the motion, the amendment, and the amendment to the amendment.

(f) When an amendment is disposed of, other relevant amendments may be proposed.

(g) The discussion is always on the immediately pending question, and it must be voted on first. When a motion, an amendment, and an amendment to the amendment are before the Court, the two first named are "pending questions" and the last is the "immediately pending question." When the immediately pending question is disposed of, the one above it then becomes the immediately pending question, until the whole matter is disposed of.

(h) When an amendment carries, it is not thereby adopted as the finding of the Court, but only changes the proposition under discussion.

(i) When a motion, an amendment, and an amendment to the amendment are before a Court, three (3) separate votes including "for" and "against" must be taken. The first determines whether the amendment shall be amended, the second determines whether

the motion shall be amended, and the third determines whether the motion, in whatever form it is then before the Court, shall be adopted or rejected.

### 7. Procedure on Voting

(a) A vote is generally taken viva voce or by a show of hands. The Presiding Officer may ask for a standing vote. Upon motion duly passed, the vote shall be taken by ballot. In all actions of Church Courts regarding membership in the Order of Ministry requiring voting procedure, the vote shall be taken by ballot unless waived by unanimous consent; that is, on motion to waive, no dissenting vote is cast. See also sections C.5.7 and D.4.4 of the bylaws.

(b) In the event of a tie, the Presiding Officer shall cast the deciding vote.

(c) An affirmative vote on a motion does not validate any motion that is ultra vires of the Court, or that contravenes a decision of a higher Court.

(d) In the conduct of United Church business, voting by proxy or by mail-in ballot is not permitted. Voting by telephone or by email is permitted only when it occurs during a meeting that is held in a manner that allows all of the persons participating to communicate with one another simultaneously and instantaneously.(2010)

### 8. Procedure on Motion to Reconsider

(a) A motion to reconsider may be made at any time when the floor is vacant; but the actual reconsideration has only the same priority as the motion to be reconsidered.

**(b)** A motion to reconsider must be moved by a member who voted with the majority. Any member may second.

(c) If a motion to reconsider is dealt with at the same meeting in which the original motion was adopted, it will fail unless two-thirds (2/3) of those voting are in favour thereof. If a motion to reconsider is dealt with at a subsequent meeting of the Court, a majority of those voting determines the question.

(d) When any motion to reconsider has been duly seconded, all action on the original motion is suspended until the motion to reconsider has been disposed of. No motion to reconsider can be entertained by the Court where action has already been taken under the original motion.

(e) A motion cannot be reconsidered twice unless materially changed on the first reconsideration. If a motion to reconsider has been lost, it cannot be repeated.

(f) A motion to reconsider is debatable only when the motion to be reconsidered is debatable. It cannot be amended, postponed indefinitely, or committed.

### 9. Motion to Refer

A motion to refer is debatable, but only as to the wisdom and manner of the proposed referral. It requires only a majority of those voting.

#### **10. Motion to Postpone Indefinitely**

A motion to postpone indefinitely, when in order, must be put without debate. If the motion is lost, it cannot be repeated or reconsidered. If carried, the motion along with all amendments is removed from debate. At any time it may be brought back before the Court by motion duly seconded and carried. In such case the question is before the Court in exactly the position it held at the time it was removed from debate. A motion to postpone indefinitely can have no conditions attached to it. If a time is specified, it immediately ceases to be a motion to postpone indefinitely and becomes a motion to postpone definitely and is debatable.(2007)

### **11. Motion to Take an Immediate Vote**

If a motion to take an immediate vote (for which a two-thirds (2/3) vote is required) is carried, the vote shall be taken immediately. The mover of the main motion, however, shall have the right to reply before the vote is taken. If such a motion fails, debate on the main motion shall continue. A motion to take an immediate vote is not debatable.

### 12. Motion to Adjourn

A motion to adjourn is intended to suspend a meeting until another time. A motion to adjourn is in order only if there is already an agreed-upon time and place for resuming the meeting, or if the motion specifies a time and place for resuming the meeting. A motion to adjourn requires a seconder. Only the conditions attached to the motion to adjourn, such as time and place for resuming the meeting, are debatable; the wisdom of adjourning is not debatable.(2010)

### 13. Closing a Meeting (2010)

(a) A motion to close is intended to terminate a meeting. A new meeting may commence, at a future time, by previous agreement or by call. There can be no conditions attached to a motion to close. A motion to close requires a seconder. A motion to close is not debatable.(2010)

**(b)** When all the business and purposes of a meeting have been attended to and the Presiding Officer is satisfied that there is no further business before the Court, the Presiding Officer may declare that the meeting is closed, without the need for a motion to close.(2010)

### 14. Committee of the Whole

(a) Any Court, for greater freedom of discussion, may, on motion duly made, seconded, and carried, move into a Committee of the Whole. Any such motion is neither debatable nor amendable, except only as to the scope of the subject to be discussed. The motion is not in order if there is a pending motion to adjourn the meeting or to postpone discussion on the subject. (2007)

**(b)** The first act of the Committee of the Whole is to appoint a chairperson and a secretary. A separate minute of the proceedings is taken.(2007)

(c) The ordinary limitations of debate do not prevail in the Committee of the Whole. The chairperson restates the matter(s) to be considered. Discussion is then opened and is conducted informally. Motions need not be seconded. Unless the resolution creating the

Committee of the Whole imposes restrictions, there are no restrictions, within reason, on the number of times a member may speak or on the length of speeches, except that priority is given to a member who has not yet spoken.(2007)

(d) When the deliberations of the Committee of the Whole are concluded, the Committee will dispose of a motion that the Committee rise and report; this motion does not require seconding and is neither debatable nor amendable. When this motion is passed, a report is prepared and submitted to the chairperson of the main meeting, who reconvenes the main meeting.(2007)

(e) A Committee of the Whole can neither adjourn nor terminate; it only can report back to the main meeting. It can, of course, recess briefly to prepare its report.(2007)

### 15. General

(a) When a member utters language that another member considers offensive, the latter may require that the words be taken down. The speaker is then allowed to proceed. When the speaker yields the floor, the words complained of may be considered and dealt with. Such words may not be privileged.

(b) Members of any Court should at all times therein conduct themselves with dignity, fairness, and understanding. The prime concern should be the good order and welfare of the church.

(c) In any point not covered in The Manual, the parliamentary rules accepted in Canada (Bourinot) shall be followed.

## **Enabling Motions**

### 1. <u>Regional Council Roll:</u>

That the Ministerial Roll of the Regional Council and the non-Ministerial Roll of the Regional Council thus constituted be now taken as read.

2. <u>Other Delegates</u>:

That anyone who has a role to play at the General Meeting of the Conseil régional Nakonha:ka Regional Council (e.g. members of the Regional Council Executive, Chairs of Leadership Teams and who has not been appointed as a delegate by her/his Community of Faith, be a full delegate with all the privileges of other delegates, and that the youth and young adult representatives from each Community of Faith be full delegates.

### 3. <u>Corresponding Members</u>:

That the students serving this Regional Council; the candidates for Ordination and Admission, those present as invited guests of this Regional Council, resource persons, all who have registered for the Youth and Young Adult Event and other guests recognized by this court, be invited to sit as corresponding members of the Court.

 <u>Minimum Number of Members at Meetings</u>: That the minimum number of members for any session of this Regional Council is present (C.4.3, The Manual 2019).

### 5. <u>Agenda</u>:

That the agenda as printed and circulated, the reports, and the daily Agenda, be adopted as the Agenda for this meeting, subject to such changes as may be determined by the Business Leadership Team and approved by this Court.

### 6. <u>Procedures for Reports</u>:

That the following procedure with respect to reports being presented at the Regional Council be adopted.

- a. Reports and any attendant recommendations be dealt with in the allotted time.
- b. If action has not been completed in the allotted time, then the Regional Council may:
  - i. Request that additional time on the Agenda be arranged by the Business Leadership Team
  - ii. Refer the report with its recommendation(s) to the appropriate body or bodies concerned, along with power to issue
  - iii. Refer the report with its recommendation(s) to the Executive of the Regional Council for such action as the Executive deems appropriate.

## 7. <u>Meeting of the Executive</u>:

That the Executive (which is empowered to act on behalf of the Regional Council between the meetings of the Court) be empowered to meet, if necessary, during the sessions of this Regional Council meeting and report those matters which require the approval of this Court.

8. <u>Inclusive Language</u>:

It is recommended that every attempt be made to use inclusive (non-sexist) language in all worship, reports, petitions and discussions in this Court.

- 9. <u>Business Leadership Team</u>: That the *Business Leadership Team* be: Chair of the Executive, Executive Minister, Chair of Planning and the coordinator of proposals
- 10. <u>Scrutineers</u>: That the *Scrutineers* be appointed from the membership of the Court.

### 11. <u>Courtesies</u>: That the *Courtesies Leadership Team* be appointed from the membership of the Court.

## 12. <u>Election of the President</u>:

That the following be the procedure for the nomination of persons to the office of President, when necessary:

- 1. That written nominations be supported by two signatures and be presented to either the Chair of the Regional Council Executive, or the Executive Minister.
- 2. That the opportunity be given for nominations from the floor, with the consent of the nominee having been previously secured.
- 3. That the election be by ballot, with a clear majority necessary for election.

### 13. <u>Advisory Leadership Team</u>:

That a Leadership Team comprised of all past Presidents of Synode Montreal & Ottawa Conference present will assist the Chair of the Regional Council Executive in dealing with matters arising on the floor of the Regional Council not already on the Agenda which may require special consideration.

Purpose: The purpose of this policy is to clarify limits of the budget process. <i>The Manual C.2.5.</i>			

### Preamble

This document outlines the Conseil régional Nakonha:ka Regional Council's policy and best practices regarding requests for funding outside of the approved annual budget at the annual meeting.

### Policy

It is the policy of the Conseil régional Nakonha:ka Regional Council to affirm and uphold the use and function of the Business Committee for matters coming to the floor of the Annual Meeting of the Regional Council.

It is the policy of the Conseil régional Nakonha:ka Regional Council that any motion committing the Conseil régional Nakonha:ka Regional Council to the expenditure of non-budgeted sums of money be required to have a budget attached;

It is the policy of the Conseil régional Nakonha:ka Regional Council that any motion committing the Conseil régional Nakonha:ka Regional Council to non-budgeted expenditures which are presented during the Annual Meeting be automatically referred to the Executive who may request input from the Property and Finance Team first before making the decision;

It is the policy of the Conseil régional Nakonha:ka Regional Council that in the interests of fairness and justice, requests for funding of projects or groups not covered in the existing Financial budgets be subject to conditions and criteria similar to those that are currently expected of requests for Mission Support, and other funds available within the Regional Council.
