\*This meeting focused on changes in Pastoral Relations; recommendations from Property & Finance Leadership Team; recommendations from the Granting & Enabling Leadership Team; discusses the implications of the decisions made by the General Council Executive, explored how to handle the translation of Executive minutes, reviewed the status of planning for the fall meeting and the progress of the strategic plan, and discerned how to address the recognition of a new community of faith as well as how we might respond to the Israel-Hamas war.

We received representatives from Saint Columba House who will give us some of the latest developments in that ministry. We also welcomed the new Responsable des ministères en français.

Land Acknowledgement and Opening Devotions – Rev. Samuel V. Dansokho shared a video of children from Senegal singing praising Jesus, and then he acknowledged all who were present with peace that is beyond all understanding. This was followed by the land acknowledgement, and Samuel invited all to acknowledge the land where they were joining the meeting from. Samuel gave thanks for the stewardship of these land by First Nations Peoples, and reminded all to continue to work towards truth and reconciliation. Samuel shared some details related to the General Council proposal about a principle-based approach for justice, highlighting some of these principles (i.e., anti-oppression, truth-telling, holistic scope, respect for human dignity, full participation and decolonization, etc.). Samuel shared the song "Give Peace a Chance". Samuel shared the following scripture (Mark 12:17) and asked all to meditate on it: "Give therefore to Caesar the things that are Caesar's and to God the things that are God's". Samuel asked, how do we respond to Jesus' exhortation? Samuel shared some of difficult nuances that the scripture presents to the listener (missionaries and rifles, peace and hunger, etc.). This was followed by all being invited to a time of intercessory prayer. Samuel closed this time of devotion with an exhortation from Paul (Philippians 4:4-9); and shared the video of children of Senegal singing and praising Jesus.

### 4. Property & Finance Leadership Team (PFLT) – Fred Braman;

### a) Hudson Pastoral Charge

Background

This memorandum and subsequent motion proposal to the members of the Property and Finance Leadership Team is to document the approval of the Bid and Contract for the construction/ major renovation of the Hudson Cote Church. Regional Council has previously approved the amount of \$1,050,000 for this project and PFLT had requested the leadership Team to approve the Bid and Contract.

This project has undergone several reiterations since 2019 and due to many factors, the technical requirements have changed along with costs leading up to this point.

I have followed the development since the start and I am recommending we approve the Bid and Contract you find in the attachments. The final bid was renegotiated with my supervision and the final CCDC contract is standard issue in the construction industry. It provides fixed pricing along with contract management under the architects' supervision.

The final quote dated 10/1/2023 will be inserted into the contract document upon signing as a revision.

I have completed a final review of the financials in the proposal. The final outlook is \$1,086,000 with taxes and a 5% contingency included. This translates to \$1,029,000 with tax rebates and is within the approved limit. There remains one major element of new construction required – septic system. It has been excluded in the construction contract but is included in the financial outlook. This will be carried out next spring under separate contract. There are minor elements excluded that will be supplied by the congregation i.e., kitchen appliances, landscaping and some painting. Construction is scheduled to start this fall (Peter Bisset).

Notes provided by Rev. Dr. Emmanuel Tehindrazanarivelo, Responsable de La Table:

French Ministries in a nutshell:

- Crossroads
- Exponential growth
- Challenges

French Ministries is at a crossroads. The ploughing done by previous leaders and the seeds sown are flourishing. The Call and Vision endorsed by the Strategic Plan are being heard by Communities of Faith that exist either within or alongside our Church. Voices are being raised, communities are emerging, men and women are engaging us in relevant, if not always comfortable, conversation. I quote:

- "You ask us about our needs all the time when we come to you. And what are your needs so that we can also contribute? There's more joy in giving than in receiving. Why deprive ourselves of that joy?

- According to the Strategic Plan, we can bring you dynamism, vitality, numbers, youth, renewal and bold creativity.

- Our needs are the physical space to pray and our activities, to create a spiritual home in symbiosis with today's society and our heritages.

- Welcoming and supportive communities to share faith and hope, and equity.

#### Exponential growth

- Faith communities are springing up all over the country at the invitation of the United Church. Some are in the exploratory phase, others are seeking partnerships, most are already in association, but how can we make our contributions known, recognize their existence and find our place in them? In Ontario (see MPFT map + house churches in Ottawa and Nepean)

and Quebec (Montreal, Longueuil, Drummondville, Joliette, Saint-Hyacinthe, Sherbrooke, Eastern Townships) alone, some forty faith communities are emerging and making themselves known. Others are in Manitoba (Winnipeg), Alberta (Edmonton, Peace River), the Atlantic coasts (New Brunswick, Nova Scotia) and the Pacific (British Columbia).

- Not all of them will be joining us, but this shows the interest our Appeal & Vision and Strategic Plan are arousing.

- Since this summer, five new candidates for ordained ministry have been in conversation with the Director of our Church Supervision Committee, and two others with the Head of MEF, who may soon join the other five.

The challenges

- Follow-up and accompaniment of these emerging communities, their integration or grafting with established communities.

- Establishing a relationship of equity in sharing and mutual welcome, to avoid a relationship of coloniality.

- Acknowledging and affirming what already exists (ministries, leaderships, etc.) within emerging communities, in dialogue with established communities.

- How can we be creative without compromising governance? And how can we ensure that governance doesn't strangle the growth of creativity and emergence?
